KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of California, and to that end we do hereby adopt, execute and acknowledge the following

ARTICLES OF INCORPORATION

and we do hereby set forth, declare and certify:

ARTICLE I.

Name

That the name of the corporation is

LAND PROJECTS MUTUAL WATER CO.

ARTICLE II.

Purposes

That the purposes for which such corporation is formed are to do, as fully and to the same extent as natural persons might or could do, any and all things following:

(a) To acquire by purchase or otherwise, land, water, water rights, works assignments, plant permits, systems and lines for the development and production of water, to develop, produce, maintain and operate the same, and distribute the water so developed and produced at cost to the stockholders of this corporation only and solely for use upon lands within the district described by the by-laws of this corporation or amendments thereof and on the terms and conditions therein set forth.

(b) To borrow or raise money for any purpose without limit as to issue bonds, notes, debentures or other obligations of this corporation from time to time for any of the objects or purposes of this corporation and to secure the same by mortgage, pledge, deed of trust, or otherwise, or to issue the same unsecured.

(c) To enter into, make, perform and carry out contracts of every kind for any lawful purpose within the purview of the Articles and By-Laws of this corporation without limit as to the amount thereof with any person, firm, association, corporation, municipality, county, state, territory, or other government subdivision.

(d) To do all and everything necessary suitable and proper for the accomplishment of any of the purposes or attainment of any of the objects or the furtherance of the powers hereinabove set forth and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid business or powers or any part or parts thereof, provided the same be not inconsistent with the by-laws of this corporation and the laws under which this corporation is organized.

(e) The several clauses contained in this statement of purposes shall be construed both as purposes and powers and the statements contained in each clause shall, except where otherwise expressed, be in no wise limited or restricted by reference to or inference from the terms of any other clauses, but shall be regarded as independent purposes and powers, and the business or purpose of this corporation is, from time to time, to do any one or more of the acts and things herein set forth.

ARTICLE III.

Place of Business

That the principal office for the transaction of the business of the corporation will be located in the County of Los Angeles, State of California.

ARTICLE IV.

Number of Shares

That the corporation is authorized to issue one class of shares of stock, the total number of shares is 2,500 and the par value of each share shall be \$1.00; and the aggregate par value is \$2,500.00.

ARTICLE V.

Directors

That the number of directors shall be three, who need not be shareholders and the names and addresses of the persons who are appointed to act as the first directors and who shall hold office until the selection and qualifications of the successors are as follows:

ROBERTA F. CADY - 1317 S. Gladys Ave., San Gabriel, Cal.

JACK GROARK - 306 West Third St., Los Angeles, Cal.

That the said number of three persons named above shall constitute the number of directors of the corporation until changed by amendment to the by-laws increasing or decreasing the number of directors as may be desired, in the manner provided by law.

ARTICLE VI.

Assessments

The directors of this corporation are hereby granted power and authority to levy and collect from time to time, as in their discretion they deem advisable, assessments upon all of the shares of stock of this corporation at any time issued and outstanding, and shall have and enjoy all of the rights and privileges with reference to such assessments as are fixed, provided and established by law in respect to corporations the directors of which have such power of assessment; provided, however, neither any assessment nor the levy thereof shall create any personal liability whatsoever against any shareholder of this corporation.

ARTICLE VII.

Management - Powers

That the general management of the affairs of this corporation shall be under the control, supervision and direction of the Board of Directors, the number and personnel of which shall be determined by the by-laws. The by-laws may also provide for such assistants to the Board of Directors and such other officers, agents, factors, and employees as may be desired.

In furtherance and not in limitation of the powers conferred by Statute, the Board of Directors is expressly authorized to make and alter the by-laws of the corporation.

This corporation may in its by-laws confer upon its Board of Directors, powers in addition to the foregoing, and in addition to the power and authority expressly conferred upon them by Statute.

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these articles in the manner now or hereafter provided by Statute, and all right conferred upon members herein are granted subject to this reservation.

B Y L A W S

The name of the Corporation shall be:

LAND PROJECTS MUTUAL WATER CO.

ARTICLE I.

Corporate Powers

The corporate powers of this corporation shall be vested in a board of three directors, and a majority shall constitute a quorum for the transaction of business.

ARTICLE II

Election of Directors

The directors shall be elected by ballot, at the annual meeting of the stockholders, to serve for one year, and until their successors are elected. Their term of office shall begin immediately after election.

ARTICLE III.

Vacancies

Vacancies in the Board of Directors shall be filled by the other directors in office; and such persons shall hold office until the first meeting of the stockholders thereafter.

ARTICLE IV.

Power of Directors

The directors shall have power:

1st: To call special meetings of the stockholders when they deem it necessary, and they shall call a meeting at any time upon the written request of stockholders holding one-third of all the capital stock.

2nd: To appoint and remove, at pleasure, all officers, agents and employees of the corporation, prescribe their duties, fix their compensation, and require from them security for faithful service.

3rd: To conduct, manage and control the affairs and business of the corporation, and to make rules and regulations, not inconsistent with the laws of the State of California, or the by-laws of the corporation, for the guidance of the officers and management of the affairs of the corporation.

4th: To incur indebtedness for the purposes of the corporation and cause to be executed and delivered therefor in the corporate name, promissory notes, deeds of trust, mortgages and other evidences of debt and security therefor, and generally to do and perform every act and deed whatsoever that may pertain to the office and powers of directors.

ARTICLE V.

Duties of Directors

It shall be the duties of directors:

1st: To cause to be kept a complete record of all their minutes and acts; and of the proceedings of the stockholders, and present a full statement at the regular annual meeting of the stockholders, showing in detail the assets and liabilities of the corporation, and generally the condition of its affairs. A similar statement shall be presented to any other meeting of the stockholders, when thereto required by persons holding at least one-half of the capital stock of the corporation.

2nd: Regular meetings of the Board of Directors shall be held on each business day, at the hour of five o'clock P.M., at 112 West Ninth Street, Los Angeles, California, or at any other place within the State of California, fixed by the quorum of said directors; said meetings to be without notice.

3rd: To supervise all officers, agents and employees and see that their duties are properly performed; to cause to be issued to the stockholders, in accordance with and subject to the provisions of the articles and by-laws, in proportion to their several interests, certificates of stock, not to exceed in the aggregate 2,500 shares. Such shares may be issued in fractions at the option of the corporation.

ARTICLE VI.

Officers

The officers shall be a President, Vice-Presidents, Secretary and Treasurer, and Assistant Secretaries; which officers shall be elected by and hold office at the pleasure of the Board of Directors. The compensation and tenure of office of all the officers of the corporation (other than directors) shall be fixed and determined by the Board of Directors.

ARTICLE VII.

President

The Board of Directors shall, at their first regular meeting, elect one of their number to act as President; and if at any time the President shall be unable to act, a Vice-President shall take his place and perform his duties; and if a Vice-President, from any cause, shall be unable to act, they shall appoint some other member of the Board to do so, in whom shall be vested, for the time being, all the duties and functions of his office.

The President, a Vice-President, or in their absence the director appointed as above provided

1st: Shall preside over all meetings of the stockholders and directors, and shall have the casting vote.

2nd: He shall sign, as President, all certificates of stock.

3rd: He shall call the directors together whenever he deems it necessary, and shall have, subject to the advice of the directors, direction of the affairs of the corporation, and generally shall discharge such other duties as may be required of him by the by-laws of the corporation.

The President, or two of the directors, may call special meetings of the directors at any time, and notice of such meetings shall be given by leaving a written or printed notice at the last known place of business or of residence of such directors; such service of notice shall be entered on the minutes of the company, and said minutes, upon being read and approved at a subsequent meeting of the Board of Directors, shall be conclusive upon the question of service. Special meetings of the Board of Directors may be held at any time and place and without notice when a majority of the directors are present and decide to hold a meeting, and all the remaining directors sign a waiver of such notice. Any and all business may be transacted at a special meeting.

ARTICLE VIII.

Secretary

The Board of Directors shall elect a secretary, and if at any time the secretary shall be unable to act, an assistant secretary shall take his place and perform his duties.

1st: It shall be the duty of the Secretary to keep a record of the proceedings of the Board of Directors and of the stockholders.

2nd: He shall keep the corporate seal of the corporation and the book of blank certificates of stock, fill in and countersign all certificates issued, and make the corresponding entries on the margin of such book on such issuance; and he shall affix said corporate seal to all papers requiring a seal.

3rd: He shall keep a proper transfer book and also a stock ledger in debit and credit form, showing the number of shares issued to and transferred by any stockholder, and the dates of such issuance and transfer.

4th: He shall keep proper account books, and discharge such other duties as pertain to his office, and is prescribed by the directors.

5th: The Secretary shall serve all notices required either by the law or the by-laws of the corporation; and in case of his absence, inability, refusal or neglect so to do, then such notices may be served by any person thereunto directed by the President or Vice-President of the company.

ARTICLE IX

Treasurer

The Treasurer shall receive and keep all funds of the corporation and pay them out as the directors may from time to time direct.

ARTICLE X.

Books and Papers

The books and such papers as may be placed on file by vote of the stockholders or directors shall at all times, in business hours, be subject to the inspection of the Board of Directors and of any stockholder in the company, or by his representative duly authorized in writing.

ARTICLE XI.

District To Be Served

The district within which shareholders may be served shall be any property in Section 29, the East one-half of Section 30, the Northeast one-quarter of Section 31, all in Township 8, North Range 13 West S.B.B.&M., County of Los Angeles, State of California and such other nearby or adjacent land as may later be added by resolution of the Board of Directors.

ARTICLE XII.

Extensions and New Facilities

All extensions of lines and new facilities, within the district, shall be constructed and paid for by the subdivider, land owner or shareholder desiring such extension of lines and new facilities; the legal title thereto shall be transferred without cost to the company and the company shall be under no compulsion or liability to furnish such subdivider, land owner or shareholder unless and until the corporation accepts such transfer. Any and all new service shall be limited to the adequacy of the company's water supply and system.

ARTICLE XIII

Certificates of Stock

Certificates of stock shall be of such form and device as the Board of Directors may direct and each certificate shall be signed by the President or Vice-President, and countersigned by the Secretary, or Assistant Secretary, and express on its face its number, date of issuance, the number of shares of which, and the person to whom it is issued.

The certificate book shall contain a margin, on which shall be entered the number, date, number of shares, and the name of the person expressed and the description of the property described in the corresponding certificate.

Said stock shall not be considered appurtenant to any given land but shall be issued and located only upon land owned, leased, rented, or in the possession of the person desiring to purchase said stock within the district defined in these by-laws or subsequent amendments thereto. Each certificate shall show the description of the land on which the share or fractional share is located.

One share of stock shall be issued for each acre in the district accepted by the corporation. The ownership of each share shall carry as incident thereto a right to have water delivered to such shareholder on land on which such share is located within the district for domestic use and such other use as has been authorized by the corporation; the amount to be delivered to each shareholder shall be that proportionate part of all the water available for distribution as the number of shares owned by him shall bear to the whole number of valid and subsisting shares then outstanding.

ARTICLE XIV.

Transfer of Stock

Shares of the corporation may be transferred at any time by holders thereof, or by attorney legally constituted, or by their legal representatives, subject to the limitations imposed by these by-laws and articles. But no transfer shall be

valid until the surrender of the certificate and the acknowledgment of such transfer is made on the books of the company.

No surrendered certificate shall be canceled by the Secretary before a new one is issued in lieu thereof; and the Secretary shall preserve the certificate so canceled as a voucher. If, however, a certificate shall be lost or destroyed, the Board of Directors may order a new certificate issued upon such guarantee by the parties claiming the same as they may deem satisfactory.

Transfers shall be made only to the classes and for the uses and purposes herein limited and described. Transfers may be conditioned, at the option of the corporation, upon the payment of all delinquent assessments and charges against the stock to be transferred as well as a reasonable transfer charge. All shares upon issuance shall be delivered to the Secretary of the corporation for safe keeping who shall give a receipt therefor.

ARTICLE XV.

The Rates, Service and Assessments

The corporation may from time to time fix rates to cover its costs and such charges shall be based upon the type of service given and upon the quantity of water used.

The company may require installation of consumer's meters, the cost of which shall be paid in advance by the consumer. All service connections shall be paid for by the shareholder in advance. Service may be discontinued for failure to pay for any assessment levied or for failure to pay for water used. Unpaid water bills shall be a charge or lien against the stock owned by the delinquent shareholder. If rates prove insufficient, the corporation may assess the stockholders to provide funds for the carrying out of any of its corporate purposes.

ARTICLE XVI.

Meetings

The annual meeting of the stockholders shall be held at the main office of the corporation in the County of Los Angeles, State of California, or at any other place designated by the Board of Directors in the call of the annual meeting, on the 5th day of February of each year, at 4:00 o'clock P.M., provided, however, that should said day fall upon a legal holiday, then said meeting shall be held at the same time on the next day thereafter ensuing which is not a legal holiday, and shall be called by notice printed in one or more newspapers published in the County of Los Angeles, State of California, as the directors may elect, for at least ten (10) days preceding the date of meeting, or by a notice in writing addressed to each stockholder

at his post office address as it appears upon the books of the corporation, and if it does not so appear, then at the principal place of business of the corporation, and deposited in the United States Post Office, postage thereon prepaid, at least ten (10) days preceding the date of said meeting. Notices of special meetings of stockholders shall be given in the same manner as annual meetings, or by a signed waiver waiving notice as required by law. If written or printed notice is given for a special meeting of stockholders, such notice shall state the time and place of such meeting and any business may be transacted at a special meeting.

No meeting of stockholders shall be competent to transact business unless a majority of the stock is represented, except to adjourn from day to day, or until such times as may be deemed proper.

At each annual meeting of the stockholders, any business may be transacted, irrespective of whether or not notice thereof has been given, and directors for the ensuing year shall be elected by ballot, to serve for one (1) year, or until their successors are elected. If, however, for want of a quorum, or other cause, a stockholders' meeting shall not be held on the day above named, or should the stockholders fail to complete their elections, or such other business as may be presented for their consideration, those present may adjourn from day to day, until the same shall be accomplished.

ARTICLE XVII.

Voting

At all corporate meetings each stockholder, either in person or by proxy, shall be entitled to as many votes as he owns shares of stock. Such proxy shall be in writing, and filed with the Secretary. In all the elections for directors, each shareholder shall have the right to cast as many votes in the aggregate as he should be entitled to vote, multiplied by the number of directors to be elected at such election; such shareholder may cast the whole number of votes for one candidate or distribute such votes among two or more candidates, and such directors shall not be elected otherwise.

ARTICLE XVIII

Amendments

The By-laws may be adopted, amended or repealed at any meeting of the stockholders at which a quorum is present by a 51 per cent vote of the stock represented at such meeting, or by a two-thirds vote of the whole number of the Board of Directors.

ARTICLE XIX.

Seal-

The company shall have a common seal consisting of a circle, and on its circumference having the words "LAND PROJECTS MUTUAL WATER CO., California, Incorporated, January 29 1948"

Policy Manual

1.0 Definitions

- 1.1 Company- Land Projects Mutual Water Company.
- 1.2 Customer- The legal owner of a parcel of land in the district of the Company.
- 1.3 Metered service- Service provided to all customers who have a metered connection; billed monthly.
- 1.4 Standby service- All properties which do not receive water, but still lie within the water district.

2.0 Customers

- 2.1 All information sent out by the water company; including bills will be sent to the primary residence of the owner of the property. The company does not send bills to renters.
- 2.2 It is the responsibility of the owner, to provide the company with the name of tenants.
- 2.2 It is the owner's responsibility to communicate the amount owed by the tenant to the water company.

3.0 Service

- 3.1 An application for water service is required for all customers both metered and standby. Failure to return application may result in loss of water rights.
- 3.2 No private wells are allowed in the incorporated mutual water company area.
- ~~X~~ | 3.3 The customer is held liable for all water service furnished until such time the customer provides proof of ownership transfer.
- 3.4 Switching between metered and standby service is allowed under the following conditions;
 - (a) Current and past due monthly bills must first be paid in full.

(b) A contract must be signed by the customer stating that if they switch back to monthly meter service, they must stay on meter for three (3) years.

(c) A fee of \$50.00 must be paid.

4.0 Billing/Assessments

- 4.1 Meters are read the 3rd Monday of every month (unless it is a holiday).
- 4.2 Bills are sent out on the 1st day of each month; unless that day falls on a day the office is closed. The bill will be sent out the next business day.
- 4.3 Payments are due on or before the 20th of the month following the meter reading.
- 4.4 There is no grace period.
- 4.5 A 15% late fee will be applied to all accounts not paid by the 20th.
- 4.6 It is the customer's responsibility to call the water company if they have not received their bill.
- 4.7 An assessment fee of \$45.45 will be applied to every metered customer for 0-40,000 gallons of water used each month. An additional charge of \$0.72 per 1000 gallons over 40,000 gallons will be applied.
- 4.8 All standby customers will be charged a standby assessment fee applied quarterly, based on acreage of each account.
- 4.9 The customer is held liable for all water service furnished to the property until such time the customer is no longer the legal owner of the property.

5.0 Non Payment

- 5.1 48 hour shut-off notices will be posted to any customer who is two (2) months behind in payment.
- 5.2 A fee of \$15 will be applied for posting of a 48 hour notice.
- 5.3 A fee of \$41.46 will be applied for turning water back on after a shut off resulting.
- 5.4 Partial payments do not prevent 48 hour notices, late fees, or shut offs.

5.5 Complete payment of the amount posted on the 48 hour notice is required to avoid shut off.

6.0 Liens

- 6.1 A lien on stock will be filed whenever a bill is three (3) months past due, or totals \$250 or more.
- 6.2 A \$200 fee is applied to all accounts needing a lien.
- 6.3 If a lien has been placed on a house that is empty, the meter will be pulled immediately and be placed on standby.
- 6.4 A lien will be placed on all HUD homes due to non-payment by Freddie-Mac, Fannie Mae, etc. without a lien.

7.0 Meters

- 7.1 All meters are accurately tested before installation. The company may periodically test meters.
- 7.2 Any customer may request the company to make a special test of the accuracy of a meter. ~~A fee is to be paid for any special test and labor incurred.~~ The fee shall be paid in advance by the customer at the time a written request is submitted at the office.
- 7.3 Should the meter be found to test incorrectly to the prejudice of the customer all testing fees shall be returned to the customer and the meter shall be repaired/replaced at the company's discretion and reinstalled at no cost to the customer.
- 7.4 Vandalism/damage to a meter will be charged to the customer.
- 7.5 If a customer removes, cuts, or breaks the lock or angel-stop on a meter a fee of \$75 will be applied to their account.
- 7.6 Broken meter charge is \$1430 plus \$86 reinstall fee for new/repaired meter.
- 7.7 Meter tamper fee is \$148.06.
- 7.8 The use of water by the same customer in different residences or adjoining parcels will not be combined and each installation shall be charged and billed separately.

- 7.9 Customers must pay additional capital Improvement Fee for each additional meter.
- 7.10 The company will prosecute violations of the Penal Code of California which make it a misdemeanor to tamper with, or bypass water meters, distribution lines or hydrants, to take water without payment or unauthorized use, or to damage or obstruct the company facilities.
- 7.11 Where the company determines there has been unauthorized use, it shall have the legal right to recover from any customer or other person who caused or benefited from such unauthorized use, the estimated undercharges for the full period of such unauthorized use.
- 7.12 Where the company determines unauthorized use is occurring, the company may refuse or discontinue service without further notice.
- 7.13 All foreclosed homes will have meter removed as soon as possible.

8.0 Connections

- 8.1 The customer shall be responsible for connecting his pipeline to the company's meters. However, except for private fire protection services, the company may make the necessary connection if the customer's pipeline is properly placed before the meter is installed.
- 8.2 Pressure Devices- Where it is desired to reduce or increase the pressure, under which the company supplies water, the customer shall be responsible for installing and maintaining the necessary regulators, pumps, or relief valves. In such cases, the equipment shall be installed on the customer's side of the meter and at his own risk and expense.
- 8.3 The customer shall, at his risk, furnish, install, maintain, repair and retain ownership and control over the pipes and water receiving equipment leading from the outlet of the districts water meter. However, if the customer's pipes or equipment cause damage, nuisance, or inconvenience to the company or its other customers, the company shall have the right to compel the owner or user of such pipes or equipment to adjust, repair, or replace the same.

- 8.4 The company shall not be responsible for any loss or damage caused by the negligent or wrongful act or omission of a customer or any of his tenants, agents, employees, contractors, licensees, or permittees, in installing, maintaining, using, operating, or interfering with any water receiving equipment.
- 8.5 The company shall not be responsible for damage caused by faucets, valves, and other equipment which may be open at any time that water is turned on at the meter.
- 8.6 No water received from the company may be resold or otherwise redirected to other persons or property without the specific approval and authorization of the company.

9.0 Public Fire Hydrants

- 9.1 The company shall install and maintain all fire hydrants in the system as required under Los Angeles County fire codes. The company shall pay for the expense of maintaining and /or improving the fire protecting system by funds supported in part by impact fees collected for Fire Protection Service. Fire protection facilities shall be inspected and maintained by the company.
- 9.2 The use of fire hydrants shall be restricted to water required for extinguishing fires.
- 9.3 Water shall not be taken from any fire hydrant for construction purposes, sprinkling streets, arenas, tracts, or livestock holding areas, flushing sewers or gutters, or for any other use unless specifically permitted by the company for the particular time and occasion stated on the individual permit.
- 9.4 The company may install private fire hydrants upon a customer's written application for Private Fire Service Connection and payment of all applicable fees and costs.

10.0 Temporary Service

- 10.1 Temporary service for construction purposes may be provided through construction meters upon written application to the company and the payment of \$165, which is a non-refundable charge for administration, installing, and removing the meter.
- 10.2 Construction meters will be installed and maintained by the company and shall not be removed or otherwise disturbed by the customer.
- 10.3 The company will relocate the meter upon request of the customer.
- 10.4 There will be a charge of \$0.72 per 1000 gallons of water used through a construction meter.
- 10.5 The customer is responsible for all water used through the meter and is responsible for any damage to the meter.

11.0 Bulk Service

- 11.1 All water sold on a bulk basis shall be from facilities designated by the company and shall only be available to shareholders.
- 11.2 A refundable deposit of \$118.45 will be required to insure against damage.
- 11.3 The charge for bulk water shall be \$17.25 for 4000 gallons of water. Each additional 1000 gallons will be \$1.15.

12.0 Service Continuity or Interruption of Service

- 12.1 The company may at any time shut off the water in the mains in case of accident, or for the purpose of making connections, alterations, repairs, changes, or for other reasons, and may restrict the use of water to reserve a sufficient supply for public fire service or other emergencies whenever the public welfare may require it.
- 12.2 Whenever possible, advance notice of interruption of service will be given to all customers affected.
- 12.3 Customers depending upon a continuous supply of water should provide themselves with emergency storage.
- 12.4 The company will not be liable for any loss, damage, or inconvenience due to interruption of or discontinuance of water service, when such

interruption of discontinuance is caused by an act of God, an unavoidable accident, a disturbance or condition of any kind that is beyond the control of the company, or when interruption is reasonably necessary for the repair, alteration, or extension of any of the districts facilities.

- 12.5 The company will use reasonable care and diligence in order to prevent and avoid interruptions and fluctuations in service but it cannot and does not guarantee that such will not occur. The company shall not be considered in any manner an insurer of property or persons, or to have undertaken to extinguish fires or to protect any persons or property against loss or damage by fire, or otherwise.
- 12.6 The company assumes no liability for loss or damages arising out of any excess or deficiency in the pressure, volume, or supply of water.
- 12.7 The company shall in no event be liable for any loss or damage caused by reasons of any break, leak, or defect in the customers own service pipe, line, or fixture.

13.0 General Interference with Facilities

- 13.1 No person shall turn the water on or off at any line valve, fire hydrant, or street connection, or disconnect or remove any meter without the consent of the company.
- ~~13.2~~ The control of the water supply by the customer shall be by means of a separate stop and waste valve on the customer's premise.
- 13.3 All service lines, meters and fixtures, including any and all fixtures within the premises receiving the supply of water, shall, at all reasonable hours, be subject to inspection by any duly authorized employee of the company.
- 13.4 Customers will not be permitted to install pumps or any other types of connections that take water directly from service pipes or water lines or mains owned by the company.

Name

Purposes

That the purposes for which such corporation is formed are to do, as fully and to the same extent as natural persons might or could do, any and all things following:

(a) To acquire by purchase or otherwise, land, water, water rights, works assignments, plant permits, systems and lines for the development and production of water, to develop, produce, maintain and operate the same, and distribute the water so developed and produced at cost to the stockholders of this corporation only and solely for use upon lands within the district described by the by-laws of this corporation or amendments thereof and on the terms and conditions therein set forth.

(b) To borrow or raise money for any purpose without limit as to issue bonds, notes, debentures or other obligations of this corporation from time to time for any of the objects or purposes of this corporation and to secure the same by mortgage, pledge, deed of trust, or otherwise, or to issue the same unsecured.

(c) To enter into, make, perform and carry out contracts of every kind for any lawful purpose within the purview of the Articles and By-Laws of this corporation without limit as to the amount thereof with any person, firm, association, corporation, municipality, county, state, territory, or other government subdivision.

That the number of directors shall be three, who need not be shareholders and the names and addresses of the persons who are appointed to act as the first directors and who shall hold office until the selection and qualifications of the successors are as follows:

That the said number of three persons named above shall constitute the number of directors of the corporation until changed by amendment to the by-laws increasing or decreasing the number of directors as may be desired, in the manner provided by law.

ARTICLE VI.

Assessments

The directors of this corporation are hereby granted power and authority to levy and collect from time to time, as in their discretion they deem advisable, assessments upon all of the shares of stock of this corporation at any time issued and outstanding, and shall have and enjoy all of the rights and privileges with reference to such assessments as are fixed, provided and established by law in respect to corporations the directors of which have such power of assessment; provided, however, neither any assessment nor the levy thereof shall create any personal liability whatsoever against any shareholder of this corporation.

ARTICLE VII.

Management - Powers

That the general management of the affairs of this corporation shall be under the control, supervision and direction of the Board of Directors, the number and personnel of which shall be determined by the by-laws. The by-laws may also provide for such assistants to the Board of Directors and such other officers, agents, factors, and employees as may be desired.

In furtherance and not in limitation of the powers conferred by Statute, the Board of Directors is expressly authorized to make and alter the by-laws of the corporation.

This corporation may in its by-laws confer upon its Board of Directors, powers in addition to the foregoing, and in addition to the power and authority expressly conferred upon them by Statute.

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these articles in the manner now or hereafter provided by Statute, and all right conferred upon members herein are granted subject to this reservation.

ARTICLE I.

Corporate Powers

The corporate powers of this corporation shall be vested in a board of three directors, and a majority shall constitute a quorum for the transaction of business.

ARTICLE II

Election of Directors

The directors shall be elected by ballot, at the annual meeting of the stockholders, to serve for one year, and until their successors are elected. Their term of office shall begin immediately after election.

ARTICLE III.

Vacancies

Vacancies in the Board of Directors shall be filled by the other directors in office; and such persons shall hold office until the first meeting of the stockholders thereafter.

ARTICLE IV.

Power of Directors

The directors shall have power:

1st: To call special meetings of the stockholders when they deem it necessary, and they shall call a meeting at any time upon the written request of stockholders holding one-third of all the capital stock.

2nd: To appoint and remove, at pleasure, all officers, agents and employees of the corporation, prescribe their duties, fix their compensation, and require from them security for faithful service.

3rd: To conduct, manage and control the affairs and business of the corporation, and to make rules and regulations, not inconsistent with the laws of the State of California, or the by-laws of the corporation, for the guidance of the officers and management of the affairs of the corporation.

4th: To incur indebtedness for the purposes of the corporation and cause to be executed and delivered therefor in the corporate name, promissory notes, deeds of trust, mortgages and other evidences of debt and security therefor, and generally to do and perform every act and deed whatsoever that may pertain to the office and powers of directors.

ARTICLE V.

Duties of Directors

It shall be the duties of directors:

1st: To cause to be kept a complete record of all their minutes and acts; and of the proceedings of the stockholders, and present a full statement at the regular annual meeting of the stockholders, showing in detail the assets and liabilities of the corporation, and generally the condition of its affairs. A similar statement shall be presented to any other meeting of the stockholders, when thereto required by persons holding at least one-half of the capital stock of the corporation.

2nd: Regular meetings of the Board of Directors shall be held on each business day, at the hour of five o'clock P.M., at 112 West Ninth Street, Los Angeles, California, or at any other place within the State of California, fixed by the quorum of said directors; said meetings to be without notice.

3rd: To supervise all officers, agents and employees and see that their duties are properly performed; to cause to be issued to the stockholders, in accordance with and subject to the provisions of the articles and by-laws, in proportion to their several interests, certificates of stock, not to exceed in the aggregate 2,500 shares. Such shares may be issued in fractions at the option of the corporation.

ARTICLE VI.

Officers

The officers shall be a President, Vice-Presidents, Secretary and Treasurer, and Assistant Secretaries; which officers shall be elected by and hold office at the pleasure of the Board of Directors. The compensation and tenure of office of all the officers of the corporation (other than directors) shall be fixed and determined by the Board of Directors.

ARTICLE VII.

President

The Board of Directors shall, at their first regular meeting, elect one of their number to act as President; and if at any time the President shall be unable to act, a Vice-President shall take his place and perform his duties; and if a Vice-President, from any cause, shall be unable to act, they shall appoint some other member of the Board to do so, in whom shall be vested, for the time being, all the duties and functions of his office.

The President, a Vice-President, or in their absence the director appointed as above provided

1st: Shall preside over all meetings of the stockholders and directors, and shall have the casting vote.

2nd: He shall sign, as President, all certificates of stock.

3rd: He shall call the directors together whenever he deems it necessary, and shall have, subject to the advice of the directors, direction of the affairs of the corporation, and generally shall discharge such other duties as may be required of him by the by-laws of the corporation.

The President, or two of the directors, may call special meetings of the directors at any time, and notice of such meetings shall be given by leaving a written or printed notice at the last known place of business or of residence of such directors; such service of notice shall be entered on the minutes of the company, and said minutes, upon being read and approved at a subsequent meeting of the Board of Directors, shall be conclusive upon the question of service. Special meetings of the Board of Directors may be held at any time and place and without notice when a majority of the directors are present and decide to hold a meeting, and all the remaining directors sign a waiver of such notice. Any and all business may be transacted at a special meeting.

ARTICLE VIII.

Secretary

The Board of Directors shall elect a secretary, and if at any time the secretary shall be unable to act, an assistant secretary shall take his place and perform his duties.

1st: It shall be the duty of the Secretary to keep a record of the proceedings of the Board of Directors and of the stockholders.

2nd: He shall keep the corporate seal of the corporation and the book of blank certificates of stock, fill in and countersign all certificates issued, and make the corresponding entries on the margin of such book on such issuance; and he shall affix said corporate seal to all papers requiring a seal.

3rd: He shall keep a proper transfer book and also a stock ledger in debit and credit form, showing the number of shares issued to and transferred by any stockholder, and the dates of such issuance and transfer.

4th: He shall keep proper account books, and discharge such other duties as pertain to his office, and is prescribed by the directors.

5th: The Secretary shall serve all notices required either by the law or the by-laws of the corporation; and in case of his absence, inability, refusal or neglect so to do, then such notices may be served by any person thereunto directed by the President or Vice-President of the company.

ARTICLE IX

Treasurer

The Treasurer shall receive and keep all funds of the corporation and pay them out as the directors may from time to time direct.

ARTICLE X.

Books and Papers

The books and such papers as may be placed on file by vote of the stockholders or directors shall at all times, in business hours, be subject to the inspection of the Board of Directors and of any stockholder in the company, or by his representative duly authorized in writing.

ARTICLE XI.

District To Be Served

The district within which shareholders may be served shall be any property in Section 29, the East one-half of Section 30, the Northeast one-quarter of Section 31, all in Township 8, North Range 13 West S.B.B.&M., County of Los Angeles, State of California and such other nearby or adjacent land as may later be added by resolution of the Board of Directors.

ARTICLE XII.

Extensions and New Facilities

All extensions of lines and new facilities, within the district, shall be constructed and paid for by the subdivider, land owner or shareholder desiring such extension of lines and new facilities; the legal title thereto shall be transferred without cost to the company and the company shall be under no compulsion or liability to furnish such subdivider, land owner or shareholder unless and until the corporation accepts such transfer. Any and all new service shall be limited to the adequacy of the company's water supply and system.

ARTICLE XIII

Certificates of Stock

Certificates of stock shall be of such form and device as the Board of Directors may direct and each certificate shall be signed by the President or Vice-President, and countersigned by the Secretary, or Assistant Secretary, and express on its face its number, date of issuance, the number of shares of which, and the person to whom it is issued.

The certificate book shall contain a margin, on which shall be entered the number, date, number of shares, and the name of the person expressed and the description of the property described in the corresponding certificate.

Said stock shall not be considered appurtenant to any given land but shall be issued and located only upon land owned, leased, rented, or in the possession of the person desiring to purchase said stock within the district defined in these by-laws or subsequent amendments thereto. Each certificate shall show the description of the land on which the share or fractional share is located.

One share of stock shall be issued for each acre in the district accepted by the corporation. The ownership of each share shall carry as incident thereto a right to have water delivered to such shareholder on land on which such share is located within the district for domestic use and such other use as has been authorized by the corporation; the amount to be delivered to each shareholder shall be that proportionate part of all the water available for distribution as the number of shares owned by him shall bear to the whole number of valid and subsisting shares then outstanding.

ARTICLE XIV.

Transfer of Stock

Shares of the corporation may be transferred at any time by holders thereof, or by attorney legally constituted, or by their legal representatives, subject to the limitations imposed by these by-laws and articles. But no transfer shall be

valid until the surrender of the certificate and the acknowledgment of such transfer is made on the books of the company.

No surrendered certificate shall be canceled by the Secretary before a new one is issued in lieu thereof; and the Secretary shall preserve the certificate so canceled as a voucher. If, however, a certificate shall be lost or destroyed, the Board of Directors may order a new certificate issued upon such guarantee by the parties claiming the same as they may deem satisfactory.

Transfers shall be made only to the classes and for the uses and purposes herein limited and described. Transfers may be conditioned, at the option of the corporation, upon the payment of all delinquent assessments and charges against the stock to be transferred as well as a reasonable transfer charge. All shares upon issuance shall be delivered to the Secretary of the corporation for safe keeping who shall give a receipt therefor.

ARTICLE XV.

The Rates, Service and Assessments

The corporation may from time to time fix rates to cover its costs and such charges shall be based upon the type of service given and upon the quantity of water used.

The company may require installation of consumer's meters, the cost of which shall be paid in advance by the consumer. All service connections shall be paid for by the shareholder in advance. Service may be discontinued for failure to pay for any assessment levied or for failure to pay for water used. Unpaid water bills shall be a charge or lien against the stock owned by the delinquent shareholder. If rates prove insufficient, the corporation may assess the stockholders to provide funds for the carrying out of any of its corporate purposes.

ARTICLE XVI.

Meetings

The annual meeting of the stockholders shall be held at the main office of the corporation in the County of Los Angeles, State of California, or at any other place designated by the Board of Directors in the call of the annual meeting, on the 5th day of February of each year, at 4:00 o'clock P.M., provided, however, that should said day fall upon a legal holiday, then said meeting shall be held at the same time on the next day thereafter ensuing which is not a legal holiday, and shall be called by notice printed in one or more newspapers published in the County of Los Angeles, State of California, as the directors may elect, for at least ten (10) days preceding the date of meeting, or by a notice in writing addressed to each stockholder

at his post office address as it appears upon the books of the corporation, and if it does not so appear, then at the principal place of business of the corporation, and deposited in the United States Post Office, postage thereon prepaid, at least ten (10) days preceding the date of said meeting. Notices of special meetings of stockholders shall be given in the same manner as annual meetings, or by a signed waiver waiving notice as required by law. If written or printed notice is given for a special meeting of stockholders, such notice shall state the time and place of such meeting and any business may be transacted at a special meeting.

No meeting of stockholders shall be competent to transact business unless a majority of the stock is represented, except to adjourn from day to day, or until such times as may be deemed proper.

At each annual meeting of the stockholders, any business may be transacted, irrespective of whether or not notice thereof has been given, and directors for the ensuing year shall be elected by ballot, to serve for one (1) year, or until their successors are elected. If, however, for want of a quorum, or other cause, a stockholders' meeting shall not be held on the day above named, or should the stockholders fail to complete their elections, or such other business as may be presented for their consideration, those present may adjourn from day to day, until the same shall be accomplished.

ARTICLE XVII.

Voting

At all corporate meetings each stockholder, either in person or by proxy, shall be entitled to as many votes as he owns shares of stock. Such proxy shall be in writing, and filed with the Secretary. In all the elections for directors, each shareholder shall have the right to cast as many votes in the aggregate as he should be entitled to vote, multiplied by the number of directors to be elected at such election; such shareholder may cast the whole number of votes for one candidate or distribute such votes among two or more candidates, and such directors shall not be elected otherwise.

ARTICLE XVIII

Amendments

The By-laws may be adopted, amended or repealed at any meeting of the stockholders at which a quorum is present by a 51 per cent vote of the stock represented at such meeting, or by a two-thirds vote of the whole number of the Board of Directors.

Policy Manual

1.0 Definitions

- 1.1 Company- Land Projects Mutual Water Company.
- 1.2 Customer- The legal owner of a parcel of land in the district of the Company.
- 1.3 Metered service- Service provided to all customers who have a metered connection; billed monthly.
- 1.4 Standby service- All properties which do not receive water, but still lie within the water district.

2.0 Customers

- 2.1 All information sent out by the water company; including bills will be sent to the primary residence of the owner of the property. The company does not send bills to renters.
- 2.2 It is the responsibility of the owner, to provide the company with the name of tenants.
- 2.2 It is the owner's responsibility to communicate the amount owed by the tenant to the water company.

3.0 Service

- 3.1 An application for water service is required for all customers both metered and standby. Failure to return application may result in loss of water rights.
- 3.2 No private wells are allowed in the incorporated mutual water company area.
- ~~X~~ | 3.3 The customer is held liable for all water service furnished until such time the customer provides proof of ownership transfer.
- 3.4 Switching between metered and standby service is allowed under the following conditions;
 - (a) Current and past due monthly bills must first be paid in full.

(b) A contract must be signed by the customer stating that if they switch back to monthly meter service, they must stay on meter for three (3) years.

(c) A fee of \$50.00 must be paid.

4.0 Billing/Assessments

- 4.1 Meters are read the 3rd Monday of every month (unless it is a holiday).
- 4.2 Bills are sent out on the 1st day of each month; unless that day falls on a day the office is closed. The bill will be sent out the next business day.
- 4.3 Payments are due on or before the 20th of the month following the meter reading.
- 4.4 There is no grace period.
- 4.5 A 15% late fee will be applied to all accounts not paid by the 20th.
- 4.6 It is the customer's responsibility to call the water company if they have not received their bill.
- 4.7 An assessment fee of \$45.45 will be applied to every metered customer for 0-40,000 gallons of water used each month. An additional charge of \$0.72 per 1000 gallons over 40,000 gallons will be applied.
- 4.8 All standby customers will be charged a standby assessment fee applied quarterly, based on acreage of each account.
- 4.9 The customer is held liable for all water service furnished to the property until such time the customer is no longer the legal owner of the property.

5.0 Non Payment

- 5.1 48 hour shut-off notices will be posted to any customer who is two (2) months behind in payment.
- 5.2 A fee of \$15 will be applied for posting of a 48 hour notice.
- 5.3 A fee of \$41.46 will be applied for turning water back on after a shut off resulting.
- 5.4 Partial payments do not prevent 48 hour notices, late fees, or shut offs.

- 5.5 Complete payment of the amount posted on the 48 hour notice is required to avoid shut off.

6.0 Liens

- 6.1 A lien on stock will be filed whenever a bill is three (3) months past due, or totals \$250 or more.
- 6.2 A \$200 fee is applied to all accounts needing a lien.
- 6.3 If a lien has been placed on a house that is empty, the meter will be pulled immediately and be placed on standby.
- 6.4 A lien will be placed on all HUD homes due to non-payment by Freddie-Mac, Fannie Mae, etc. without a lien.

7.0 Meters

- 7.1 All meters are accurately tested before installation. The company may periodically test meters.
- 7.2 Any customer may request the company to make a special test of the accuracy of a meter. A fee is to be paid for any special test and labor incurred. The fee shall be paid in advance by the customer at the time a written request is submitted at the office.
- 7.3 Should the meter be found to test incorrectly to the prejudice of the customer all testing fees shall be returned to the customer and the meter shall be repaired/replaced at the company's discretion and reinstalled at no cost to the customer.
- 7.4 Vandalism/damage to a meter will be charged to the customer.
- 7.5 If a customer removes, cuts, or breaks the lock or angel-stop on a meter a fee of \$75 will be applied to their account.
- 7.6 Broken meter charge is \$1430 plus \$86 reinstall fee for new/repaired meter.
- 7.7 Meter tamper fee is \$148.06.
- 7.8 The use of water by the same customer in different residences or adjoining parcels will not be combined and each installation shall be charged and billed separately.

- 7.9 Customers must pay additional capital Improvement Fee for each additional meter.
- 7.10 The company will prosecute violations of the Penal Code of California which make it a misdemeanor to tamper with, or bypass water meters, distribution lines or hydrants, to take water without payment or unauthorized use, or to damage or obstruct the company facilities.
- 7.11 Where the company determines there has been unauthorized use, it shall have the legal right to recover from any customer or other person who caused or benefited from such unauthorized use, the estimated undercharges for the full period of such unauthorized use.
- 7.12 Where the company determines unauthorized use is occurring, the company may refuse or discontinue service without further notice.
- 7.13 All foreclosed homes will have meter removed as soon as possible.

8.0 Connections

- 8.1 The customer shall be responsible for connecting his pipeline to the company's meters. However, except for private fire protection services, the company may make the necessary connection if the customer's pipeline is properly placed before the meter is installed.
- 8.2 Pressure Devices- Where it is desired to reduce or increase the pressure, under which the company supplies water, the customer shall be responsible for installing and maintaining the necessary regulators, pumps, or relief valves. In such cases, the equipment shall be installed on the customer's side of the meter and at his own risk and expense.
- 8.3 The customer shall, at his risk, furnish, install, maintain, repair and retain ownership and control over the pipes and water receiving equipment leading from the outlet of the districts water meter. However, if the customer's pipes or equipment cause damage, nuisance, or inconvenience to the company or its other customers, the company shall have the right to compel the owner or user of such pipes or equipment to adjust, repair, or replace the same.

- 8.4 The company shall not be responsible for any loss or damage caused by the negligent or wrongful act or omission of a customer or any of his tenants, agents, employees, contractors, licensees, or permittees, in installing, maintaining, using, operating, or interfering with any water receiving equipment.
- 8.5 The company shall not be responsible for damage caused by faucets, valves, and other equipment which may be open at any time that water is turned on at the meter.
- 8.6 No water received from the company may be resold or otherwise redirected to other persons or property without the specific approval and authorization of the company.

9.0 Public Fire Hydrants

- 9.1 The company shall install and maintain all fire hydrants in the system as required under Los Angeles County fire codes. The company shall pay for the expense of maintaining and /or improving the fire protecting system by funds supported in part by impact fees collected for Fire Protection Service. Fire protection facilities shall be inspected and maintained by the company.
- 9.2 The use of fire hydrants shall be restricted to water required for extinguishing fires.
- 9.3 Water shall not be taken from any fire hydrant for construction purposes, sprinkling streets, arenas, tracts, or livestock holding areas, flushing sewers or gutters, or for any other use unless specifically permitted by the company for the particular time and occasion stated on the individual permit.
- 9.4 The company may install private fire hydrants upon a customer's written application for Private Fire Service Connection and payment of all applicable fees and costs.

10.0 Temporary Service

- 10.1 Temporary service for construction purposes may be provided through construction meters upon written application to the company and the payment of \$165, which is a non-refundable charge for administration, installing, and removing the meter.
- 10.2 Construction meters will be installed and maintained by the company and shall not be removed or otherwise disturbed by the customer.
- 10.3 The company will relocate the meter upon request of the customer.
- 10.4 There will be a charge of \$0.72 per 1000 gallons of water used through a construction meter.
- 10.5 The customer is responsible for all water used through the meter and is responsible for any damage to the meter.

11.0 Bulk Service

- 11.1 All water sold on a bulk basis shall be from facilities designated by the company and shall only be available to shareholders.
- 11.2 A refundable deposit of \$118.45 will be required to insure against damage.
- 11.3 The charge for bulk water shall be \$17.25 for 4000 gallons of water. Each additional 1000 gallons will be \$1.15.

12.0 Service Continuity or Interruption of Service

- 12.1 The company may at any time shut off the water in the mains in case of accident, or for the purpose of making connections, alterations, repairs, changes, or for other reasons, and may restrict the use of water to reserve a sufficient supply for public fire service or other emergencies whenever the public welfare may require it.
- 12.2 Whenever possible, advance notice of interruption of service will be given to all customers affected.
- 12.3 Customers depending upon a continuous supply of water should provide themselves with emergency storage.
- 12.4 The company will not be liable for any loss, damage, or inconvenience due to interruption of or discontinuance of water service, when such

interruption of discontinuance is caused by an act of God, an unavoidable accident, a disturbance or condition of any kind that is beyond the control of the company, or when interruption is reasonably necessary for the repair, alteration, or extension of any of the districts facilities.

- 12.5 The company will use reasonable care and diligence in order to prevent and avoid interruptions and fluctuations in service but it cannot and does not guarantee that such will not occur. The company shall not be considered in any manner an insurer of property or persons, or to have undertaken to extinguish fires or to protect any persons or property against loss or damage by fire, or otherwise.
- 12.6 The company assumes no liability for loss or damages arising out of any excess or deficiency in the pressure, volume, or supply of water.
- 12.7 The company shall in no event be liable for any loss or damage caused by reasons of any break, leak, or defect in the customers own service pipe, line, or fixture.

13.0 General Interference with Facilities

- 13.1 No person shall turn the water on or off at any line valve, fire hydrant, or street connection, or disconnect or remove any meter without the consent of the company.
- ~~13.2~~ The control of the water supply by the customer shall be by means of a separate stop and waste valve on the customer's premise.
- 13.3 All service lines, meters and fixtures, including any and all fixtures within the premises receiving the supply of water, shall, at all reasonable hours, be subject to inspection by any duly authorized employee of the company.
- 13.4 Customers will not be permitted to install pumps or any other types of connections that take water directly from service pipes or water lines or mains owned by the company.
