1 The above-entitled matter came on regularly for hearing on December 8, 2020 at 8:30
2 a.m., telephonically via CourtCall, the Honorable Jack Komar (Ret.) presiding. The appearances
3 are as stated in the record. The Court, having read and considered the Joint Status Conference
4 Statement and Request for Prove-up Hearing ("Joint CMC Statement") filed by SCI California
5 Funeral Services, Inc. ("Joshua Memorial") and parties signatory to the Joint CMC Statement,
6 and good cause appearing therefore, makes the following order:

7 Notice is hereby given that on February 5, 2021, at 9:00am, an evidentiary hearing will
8 be held to prove-up the proposed resolution of Joshua Memorial's Production Right claim, as
9 provided under Section 5.1.10 of the Judgment. Appearances shall be telephonic by CourtCall.

10 Sixteen (16) court days prior to the hearing, Joshua Memorial shall file and serve a
11 "prove-up package" including a written brief, declarations in lieu of live testimony, and related
12 evidence, together with stipulations reached with other Parties supporting Joshua Memorial's
13 Section 5.1.10 Production Right claim.

14 Nine (9) court days prior to the hearing, any Stipulating Party with standing to object to
15 Joshua Memorial's claim or evidence shall file and serve objections thereto, together with the
16 legal, technical and factual basis for such objections, and shall give notice of intent to appear at
17 the hearing.

18 If no such objections are filed, and if the Court has no objection, the Court may consider
19 deeming the Joshua Memorial evidence and declarations in lieu of testimony admitted into
20 evidence, and enter an order establishing Joshua Memorial's right to produce groundwater and
21 pay any applicable assessments.
