2 SCI CALIFORNIA FUNERAL SERVICES INC. DBA JOSHUA MEMORIAL PARK  
3 (“Joshua Memorial”) by and through its attorneys of record, Gresham Savage Nolan & Tilden,  
4 PC, by Derek R. Hoffman and Michael Duane Davis, submits the following information and  
5 materials, under penalty of perjury, in response to the *Stipulation and Order for Discovery*  
6 *Regarding SCI California Funeral Services, Inc., A California Corporation dba Joshua*  
7 *Memorial Park’s Groundwater Production Right Claim* of November 14, 2019 (“Order”) issued  
8 by the Honorable Jack Komar, Trial Judge.

9 Joshua Memorial has made a good faith effort to fully and accurately respond to the  
10 categories of information required by the Order. Joshua Memorial reserves the right to  
11 supplement its responses to the extent it requires, in as timely a manner as possible, in  
12 accordance with the Order.

13  
14 **Order ¶ 1.a: Groundwater extraction and diversion reports filed pursuant to Water Code**  
15 **section 5001 et seq. for the years 2000 through 2014, or a statement under oath that no such**  
16 **reports have been filed.**

17 **Response to Order ¶ 1.a:** To the best knowledge of Joshua Memorial and based upon a diligent  
18 search and review of Joshua Memorial’s business records, Joshua Memorial did not file  
19 groundwater extraction and diversion reports as provided in Water Code section 5001 et seq. for  
20 the years 2000 through 2014.

21  
22 **Order ¶ 1.b: All electrical records relating to Joshua Memorial’s groundwater production**  
23 **well for years 2000 through 2014.**

24 **Response to Order ¶1.b: Attachment “1.b.i.”** to this response contains true and correct copies  
25 of the following documents:

response to Joshua Memorial’s Deposition Subpoena for Production of Business Records.

- Edison well pump tests dated January 6, 1984 (estimating 108.1 pumped acre-feet per year); April 14, 1988 (estimating 167.5 pumped acre-feet per year); and October 17, 1990 (estimating 115.2 pumped acre-feet per year), provided by Edison on February 26, 2020 in response to Joshua Memorial’s Deposition Subpoena for Production of Business Records. In its response to the Subpoena, Edison explained with respect to these reports that some Edison data was lost including the name and contact number of the person who performed the test and the cost savings per Kwh that could be achieved. The contact information is therefore blank and the cost information is stated as “\$0.00”. Edison further explained that the date indicated at the top of the reports is the date the reports were pulled from Edison’s database but the actual date of the test results is as indicated in the body of the reports. Finally, Edison explained that the manager listed at the bottom of the reports (Russ Johnson) is the current manager of the Edison pump test department and not the manager at the time these reports were first issued.

**Order ¶ 1.c.: The acreage under irrigation with well water at Joshua Memorial’s property for each year from 2000 through 2014.**

**Response to Order ¶1.c.** The acreage under irrigation with well water at Joshua Memorial’s property for each year from 2000 through 2014 is estimated to be an average of approximately 19 acres. The maximum estimated irrigated acreage during that timeframe is estimated to be approximately 21.4 acres in 2003, and the lowest estimated irrigated acreage during that timeframe is estimated to be approximately 18.3 acres from 2004 to 2013. **Attachment “1.c”** to this response contains true and correct copies of the following documents:

**Order ¶ 1.e.: The periods, if any, between 2000 and 2015 that the mobile home on the Joshua Memorial property was connected to the electrical meter serving the groundwater well and, if connected, the periods during which the mobile home was occupied.**

**Response to Order ¶ 1.e.**: To the best of Joshua Memorial’s knowledge and based upon a diligent search and review of Joshua Memorial’s business records and information, the mobile home on the Joshua Memorial property was connected to the electrical meter serving the groundwater well throughout the 2000 to 2015 timeframe, and was occupied as follows:

- 2000 – 2002: unoccupied
- 2003 – 2006: occupied by one groundskeeper, who subsequently passed away
- 2007 – 2008: unoccupied
- 2009 – 2011: occupied by one groundskeeper
- 2011 – Current: unoccupied and used as extra storage space

During the course of gathering information for this discovery response, Joshua Memorial determined that the approximately 30’ x 60’ maintenance shop structure located south of the well, is connected to the same electrical utility line as the well and the mobile home. The maintenance shop is used for material and equipment storage and repairs and for parking maintenance vehicles. The maintenance shop has a couple interior lights and few outlets inside, and a couple exterior lights. The Joshua Memorial sprinkler system control panel is also located within the maintenance shop. There is an old, rusty air conditioning condenser outside the maintenance shop, which is disconnected inside the maintenance shop and has been for years (the exact time it was disconnected is not currently known). Based upon Joshua Memorial’s current practices, and to the

1 best of Joshua Memorial's knowledge, the maintenance shop electrical features are rarely used and  
2 draw very limited electricity. **Attachment "1.e."** to this response contains true and correct copies  
3 of the following documents:

- 4 • Pictures of the mobile home taken in April 2020 showing the mobile home unit used as  
5 storage.
- 6 • Pictures of the mobile home, old well pump and equipment and surrounding area, taken  
7 by LSCE in April 2019.
- 8 • Pictures of the well and hydropneumatic tank taken in May 2019.
- 9 • Pictures of the maintenance shop and surrounding area, taken in April 2020.
- 10 • Building permits for what Joshua Memorial believes to be the maintenance shed, dated

The Regional Planning Commission respectfully recommends that your Honorable Board adopt an order granting a permit under the provisions of Zoning Ordinance No. 1494, in subject case.

The Zoning Board found; 1) that the establishment and maintenance of the proposed cemetery will not jeopardize nor adversely affect public health, safety, comfort or welfare; and 2) that such establishment and maintenance will not constitute a public nuisance; 3) that the establishment and maintenance of the cemetery will not adversely affect the free movement of traffic, nor will it interfere with the movement of police, ambulance, or fire equipment; 4) that the applicant proposes to establish a perpetual care fund.

The Zoning Board recommended that the cemetery permit be granted, subject to the following conditions:

1. That the entire area be placed under the perpetual care fund.
2. That applicant dedicate such property along the northernly side of the cemetery site as may be necessary to provide a 40-foot right of way easterly of the center line of Avenue I-5 as established by the County Surveyor, and such property along the easterly side of the cemetery site as may be necessary to provide a 40-foot right of way westerly of the center line of 10th Street east, as established by the County Surveyor.

The public hearing before the Zoning Board was held September 15, 1949; findings and recommendations reported to the Commission, 9-21-49 and the Commission by unanimous vote determined that the exception herein recommended, under conditions set forth, was consistent with the intent and purposes of the Zoning Ordinance.
