MINUTE ORDER: **STATUS CONFERENCE** This Status Conference was set by the Court as a follow-up to the August 15, 2014 status conference regarding the pending settlement.

**Wood Class Attorneys' Fees**

Parties present reported that the Wood Class Attorneys' Fees issue remains unresolved; a further mandatory meet and confer session has been set by Attorney Jeffrey Dunn for Wednesday, September 3, 2014 at 10:00 a.m. at the Los Angeles office of Best, Best & Krieger; parties shall contact Attorney Wendy Wang for confirmation and/or to set up appearances by telephone. Parties shall report back with a status report to the Court on **Friday, September 5, 2014 at 9:00 a.m. (via CourtCall)**.

**Phelan Piñon Hills Community Services District ("PPH")**

Trial on the issues relating to PPH remains set for October 7, 2014. Each party must file its Notice of Intent to Participate no later than September 9, 2014. Those parties filing a Notice of Intent to Participate must be present at the Status Conference on September 26, 2014 (see below). Disclosure of Percipient Witnesses with a summary statement of anticipated testimony and Designation of Experts shall be due by September 9, 2014. Trial briefs are due by October 1, 2014.

The issue as to whether PPH's 2<sup>nd</sup> cause of action (Appropriative Right) and 6<sup>th</sup> cause of action (Recapture of Return Flows) will be heard at the next phase of trial was discussed by the parties and the Court; a Further Status Conference on these PPH issues is set for **Friday, September 26, 2014 at 10:00 a.m. in Department 17, Superior Court of California, County of Santa Clara**; parties may appear by telephone (CourtCall). An updated statement from Phelan Piñon Hills shall be due by September 22, 2014; oppositions and responses thereto shall be due by September 25, 2014. In addition, PPH's motion in limine on the issue of surplus in the local/regional Southeast area of the aquifer will be heard on September 26, 2014.

**Blum Trust**

Attorney Sheldon Blum confirmed that he will contact the Court in September to schedule a December 2014 hearing on motion by the Blum Trust for summary judgment.

**Other Issues**

The Court will be unavailable from September 10, 2014 through September 21, 2014.

The Court advised Attorney Walter Wilson, representing Antelope Valley Mobile Estates, LLC, ("AVME") to contact Attorney Jeffrey Dunn as soon as possible to establish whether AVME will be part of the Wood Settlement Class.
