24 I, Donna Hopkins, declare:

- 25 1. I have personal knowledge of the facts set forth in this declaration, unless
26 otherwise stated, and I could and would competently testify thereto in court under oath if
27 called upon to do so
28 2. I live at 8531 E. Nugent, Lancaster, CA 93535 and I have lived there for about 28

1 years. I am a shareholder in Reesedale Mutual Water Company by virtue of my ownership
2 of that property. My lot is not attached to any other source of water other than
3 Reesedale's wells and I do not obtain water from any other source. I have a water meter
4 on my property, as do all of the other properties served by Reesedale.

5 2. I have been responsible for reading the water meters for the properties served by
6 Reesedale for more than 20 years, so I am quite familiar with those properties, all of
7 which are residential. None are businesses. I read the meters at the end of each month
8 and then provide my figures to the person responsible for keeping the records at
9 Reesedale, who is now Patricia Parker, the Secretary-Treasurer. I am currently the Vice-
10 President of the Board of Directors of Reesedale.

11 3. Reesedale does not provide water to anyone other than its shareholders and never has
12 to my knowledge.

13 I declare the foregoing to be true and correct under penalty of perjury under the
14 laws of the State of California. This declaration was executed in Los Angeles County,
