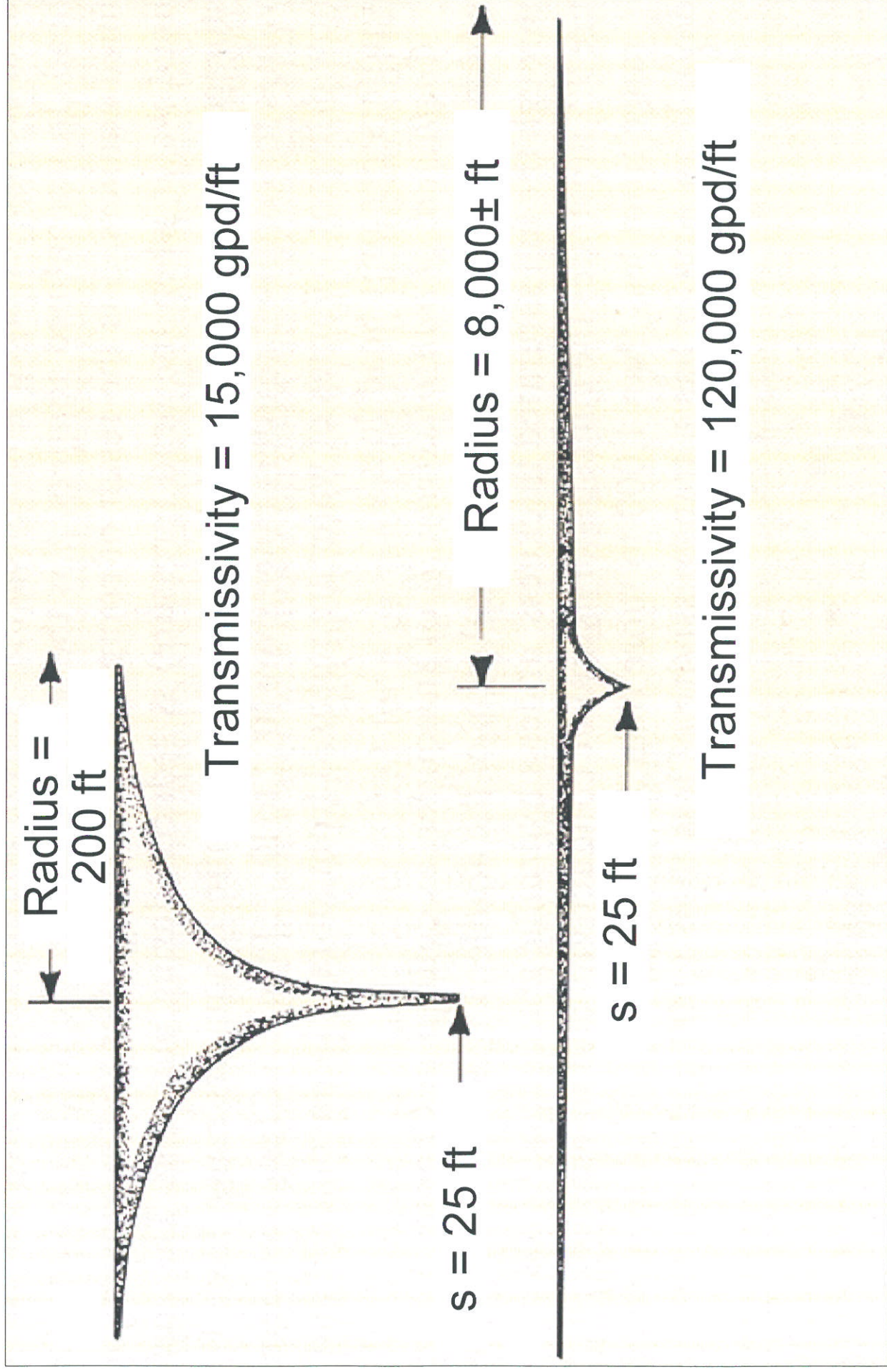
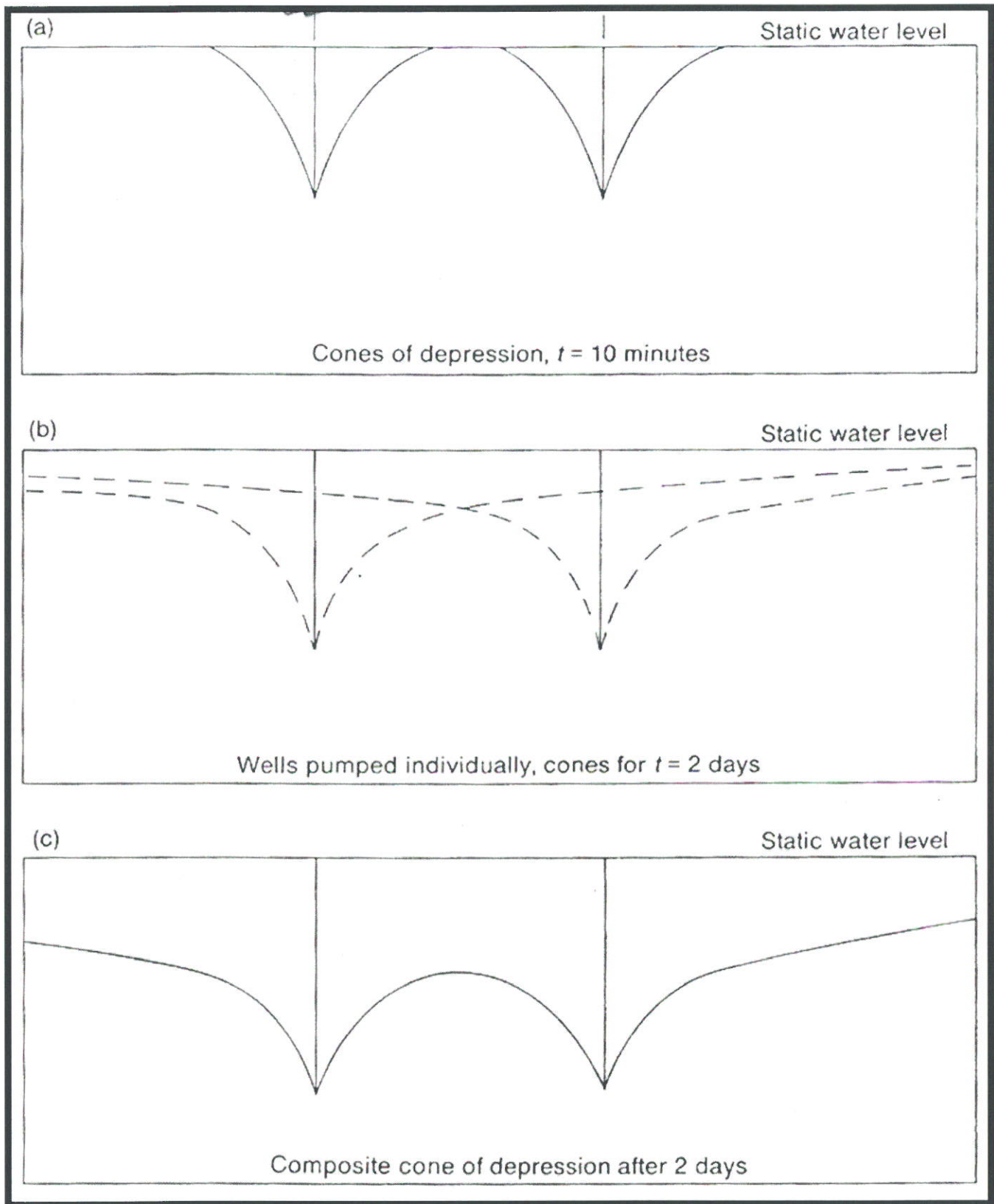

# Effects of Aquifer Characteristics on Magnitude and Extent of Pumping Impacts



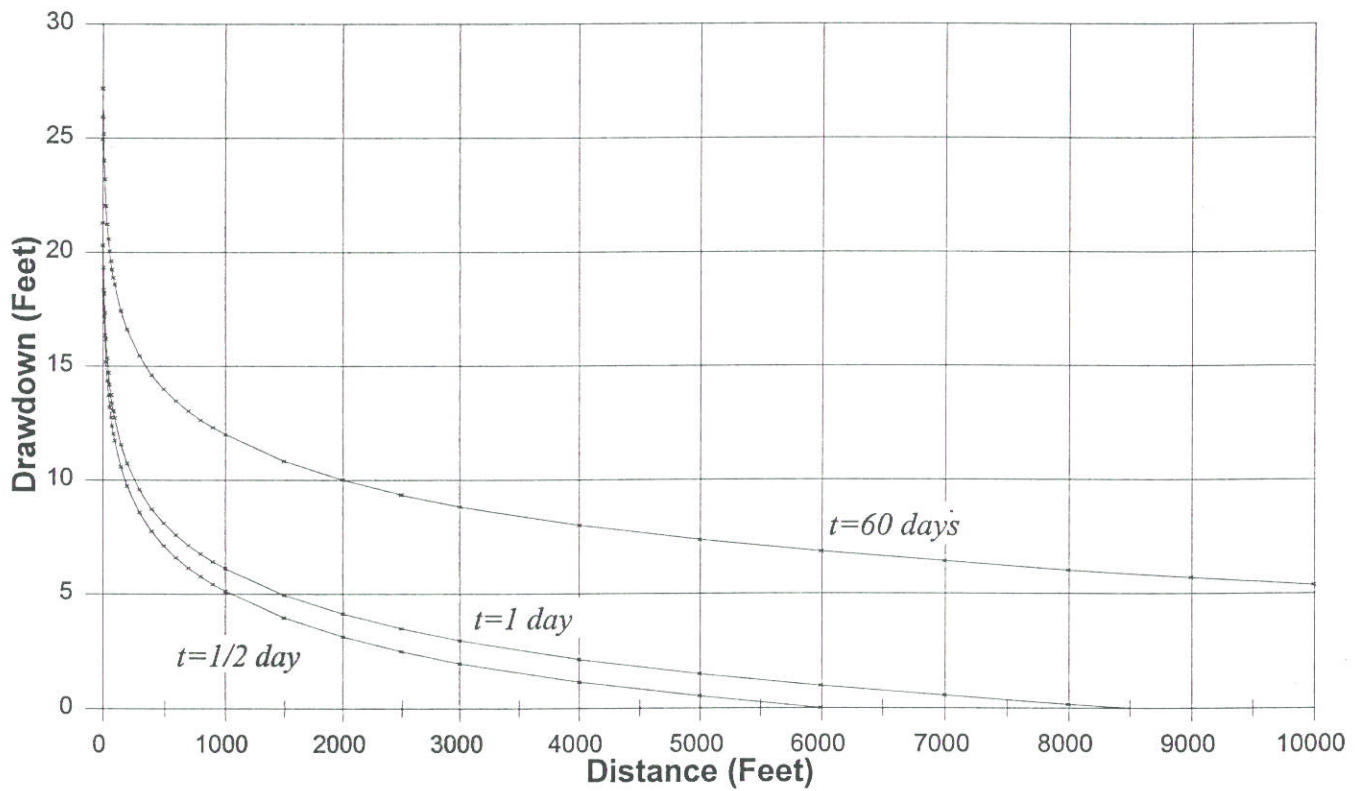


## Mutual Pumping Interference


