3 to **March 8, 2010 at 10:00 a.m. in Department 1, Los Angeles County Superior Court.**


4 The parties are ordered to submit proposals for the issues remaining to be tried,

12 of trial, in mid or late July 2010 or early August 2010. The location of the trial will be in
13 Department 1, Los Angeles County Superior Court.
