MINUTE ORDER RE: **IN-CAMERA CONFERENCE CALL REGARDING LITTLE BALDY MUTUAL WATER COMPANY**

An in-camera conference call regarding Little Baldy Mutual Water Company was completed today. Present on the conference call initiated by the Court were: Honorable Judge Jack Komar, Mr. Wayne K. Lemieux (Lemieux & O'Neill), Ms. Christine Carson (Lemieux & O'Neill), Mr. James McDonald, Jr. (Little Baldy Mutual Water Company) and Rowena Walker (Clerk, Santa Clara County Superior Court).

Mr. McDonald indicated that he will sign the waiver of conflict and return same to Mr. Lemieux as soon as possible. Accordingly, the hearings scheduled for March 29, 2010 are taken off calendar, including the (1) motion by Lemieux & O'Neill to withdraw as counsel for Little Baldy Mutual Water Company, and (2) motion by the Wood Plaintiffs for an order disqualifying the law firm of Lemieux & O'Neill.
