The Public Water Producer parties are ordered to file responses to the irregularly filed Notice and Objection of the Van Dam parties and Antelope Valley Storage LLC to "Failure to Join Indispensable Party." Van Dam parties, et al., are ordered to file an appropriate motion following such response if deemed necessary and appropriate. Any such hearing may be telephonic, if requested by any party.
