## MINUTE ORDER: FURTHER CASE MANAGEMENT CONFERENCE

The Request filed by Attorney James W. Lewis, on behalf of A.C. Warnack, as Trustee of the A.C. Warnack Trust, to join the Wood Class is approved by the Court; the Order will be signed and posted online.

The Stipulation to dismiss Little Baldy Mutual Water Company is approved by the Court. This stipulation was submitted by Attorney Jeffrey V. Dunn, on behalf of Los Angeles County Waterworks District No. 40. The stipulation was also approved by various water providers.

A discussion was held on AGWA's [Proposed] Third Amendment to Case Management Order for Phase 4 Trial, submitted by Attorney Michael T. Fife. The request for depositions to take place in the Antelope Valley within Los Angeles County was denied by the Court. The request that depositions, when set, have a specific focus, is granted by the Court: the party wishing to take the deposition shall state the area of inquiry with specificity in the notice of deposition. The Court's schedule is amended to reflect that the previously set Order to Show Cause hearing, set for March 15, 2013, be rescheduled to March 25, 2013, and be re-designated as "hearings on approval of stipulations of the parties on evidence relevant to the Phase 4 Trial."
