

All parties claiming prescriptive rights in the Antelope Valley Adjudication Area (AVAA) are hereby ordered to provide the following information and materials on or before **April 4, 2014** by posting the same to the Court's website (www.sceffiling.org).

I. DEFINITIONS

- A. "DOCUMENT" has the same meaning as the word "writing" as defined in Evidence Code section 250.
- B. "PERSON" means "person as defined in Evidence Code section 175.
- C. "YOU" or "YOUR" means the responding party, its representatives, directors, officers, agents and employees or any other PERSON acting on its behalf.
- D. "AVAA" means the Antelope Valley Area of Adjudication as defined by court order dated March 12, 2007.
