MINUTE ORDER:

CONFERENCE CALL/CASE MANAGEMENT CONFERENCE

The Court set this conference call, on its own motion, to discuss the remaining trial schedule.

The following counsel confirmed their requests for additional witness testimony:

- Mr. McElhaney, for AVEK, witnesses are Charles Binder, Robert Wagner and Dan Flory;
- Mr. Brumfeld, for Charles Tapia, witnesses are the representatives of AVEK and Southern California Edison;
- Mr. Kalfayan, for the Willis Class, various witnesses;
- Mr. Berger, for Southern Kern Unified School District/Rosamond School Water System stated he will present a witness to testify to the facts stated in its declaration.

Attorneys Tom Bunn, Jeff Dunn, Christine Carson objected to the witness testimony of David Estrada and Ray Stewart (both are witnesses for the Willis Class). The Court will permit 15 minutes each of direct testimony for Mr. Estrada and Mr. Stewart.

The Court confirmed that it will not be in session on Tuesday, October 13, 2015. Trial will resume on Wednesday, October 14, 2015 at 9am-5pm, continuing through Thursday, October 15, 2015. The trial will continue at the Mosk Court House, Room 222, 2nd Floor, Superior Court of California, County of Los Angeles, 111 N. Hill Street, Los Angeles, California 90012. Witnesses are to be available as required. Closing arguments will be discussed on October 15, 2015, and the Court invites counsel's input on a schedule for closing arguments.

The Court takes under submission the issue between Copa de Oro and the Willis Class, particularly as it relates to the following documents (hyperlinks are attached) and whether the Willis Class has the right to cross-examine Copa de Oro.
