STIPULATION

- 3. The Public Water Suppliers reserve the right to depose Robert Bowcock during discovery for subsequent trial phases or in the event the Court continues the Phase 4 trial to a date other than February 11, 2013; and
- 4. The Public Water Suppliers reserve their right to challenge the testimony of Robert Bowcock at trial.
