
1. Groundwater pumping by Gene Bahlman during the calendar year 2011 was 5.25 af.
2. Groundwater pumping by Gene Bahlman during the calendar year 2012 was 5.25 af.
3. Consistent with the Court's Case Management Order, as amended, for the Phase 4 Four trial of this matter, Gene Bahlman and the undersigned parties reserve, for a future phase of this action, determination of all other facts and legal issues in this action, including but not limited to:
 - A. The determination of the groundwater rights of Gene Bahlman, including the applicability and application of all constitutional, statutory and decisional law;
 - B. The ability to introduce in a later trial phase evidence of water use in years other than 2011 and 2012; and
 - C. The determination of the reasonableness of water use by Gene Bahlman during the period 2000 to 2012.




