- 1. Groundwater pumping by Robert Jones for R&M Ranch and Gailen and Julie Kyle during the calendar year 2011 was 9,108 af collectively.
- 2. Groundwater pumping by Robert Jones for R&M Ranch and Gailen and Julie Kyle during the calendar year 2012 was 9,442 af collectively.
- 3. Consistent with the Court's Case Management Order, as amended, for the Phase Four trial of this matter, Robert Jones for R&M Ranch and Gailen and Julie Kyle and the undersigned parties reserve, for a future phase of this action, determination of all other facts and legal issues in this action, including but not limited to:
- A. The determination of the groundwater rights of Robert Jones for R&M Ranch and Gailen and Julie Kyle, including the applicability and application of all constitutional, statutory and decisional law;
- B. The ability to introduce in a later trial phase evidence of water use in years other than 2011 and 2012; and
- C. The determination of the reasonableness of water use by Robert Jones for R&M Ranch and Gailen and Julie Kyle during the period 2000 to 2012.
