STIPULATION FOR PHASE IV TRIAL RE
2011-12 GROUNDWATER PUMPING BY
RICHARD NELSON AND WILLOW
SPRINGS CO.

1 Richard Nelson and Willow Springs Co., and the parties that have signed this Stipulation
2 agree and stipulate, for the purposes of determining groundwater pumping during 2011 and 2012
3 for the Phase 4 trial only, as follows:

4 1. Groundwater pumping by Richard Nelson and Willow Springs Co. during the calendar
5 year 2011 was 168.2 af.

6 2. Groundwater pumping by Richard Nelson and Willow Springs Co. during the calendar
7 year 2012 was 193.1 af.

8 3. Consistent with the Court's Case Management Order, as amended, for the Phase 4 Four
9 trial of this matter, Richard Nelson and Willow Springs Co. and the undersigned parties reserve,
10 for a future phase of this action, determination of all other facts and legal issues in this action,
11 including but not limited to:

12 A. The determination of the groundwater rights of Richard Nelson and Willow Springs
13 Co., including the applicability and application of all constitutional, statutory and decisional law;

14 B. The ability to introduce in a later trial phase evidence of water use in years other than
15 2011 and 2012; and


16 C. The determination of the reasonableness of water use by Richard Nelson and Willow
