The motion of the Antelope Valley Groundwater Agreement Association ("AGWA") for an order excluding from introduction into evidence at the Phase V trial testimony and data related to or arising out of model runs performed by Dr. Dennis Williams, the Public Water Suppliers' designated expert witness in Phase V, was heard by the Court on February 10, 2014.

The Court, having considered the pleadings and others papers submitted and heard the arguments of counsel, finds as follows on the matters contained in the motion: 1. AGWA and other parties would be unduly prejudiced if the Court were to admit Dr. Williams' modeling results and testimony into evidence. 2. Any comment on or attempted display of the above evidence is improper and unduly prejudicial to AGWA. (Evid. Code, § 352.) Accordingly, IT IS ORDERED that the motion is GRANTED. The following evidence will be excluded from introduction by any party at the Phase V trial: 1) Any and all testimony by Dr. Dennis Williams relating to groundwater modeling of the Basin; and 2) any and all testimony or data relating to model runs performed by Dr. Williams.
