1 The court has requested information on settlement prospects. Littlerock Creek Irrigation District,
2 et al., has been a party to the “Justice Robey mediations” and to an earlier mediation. We have not
3 participated in a mediation effort sponsored by landowners. We know enough about the landowners’
4 discussions to offer the following.

5 Settlement depends on a physical solution. A physical solution requires quantification of safe
6 yield. Quantification is a scientific question. The landowners do not agree quantification is a scientific
7 question nor do they offer a scientific support for an amount. Even if all parties agree on the quantity of
8 safe yield, such an agreement does not guarantee a scientific decision.

9 Only the court can resolve this controversy in a timely manner. Delaying the trial for settlement
10 discussions will delay resolution of this matter.
