On January 16, 2013, at the Case Management Conference in the above-captioned matter held at Santa Clara County Superior Court, in Department 1, located at 191 North 1st Street, San Jose, California 95113, the Honorable Jack Komar presiding, Attorney Sheldon Blum met and conferred with counsel for Wm. Bolthouse Farms, Inc. and Bolthouse Properties, LLC regarding deposition of a person most knowledgeable from Bolthouse regarding groundwater applied on crops grown by Wm. Bolthouse Farms, Inc. on property owned by the Blum Trust. Following discussion with counsel, the following is **ORDERED**, **ADJUDGED AND DECREED**:

That Bolthouse will designate a person most knowledgeable to testify regarding the crops grown on the Blum Trust property and to estimate water applied thereon, during any applicable time periods during which Bolthouse leased the property from the Blum Trust. Bolthouse also will produce documents that are available as of the date of this deposition related to the witness' testimony regarding such water use on the Blum Trust property. The deposition will occur sometime the week of February 4, 2013, and will last no more than six (6) hours. The Blum Trust deadline to submit its declaration/stipulation is extended from January 31, 2013 to February 8, 2013.
