Dear Counsel and All Unrepresented Parties:

Approximately thirty people participated in last Thursday’s court ordered meet and confer session. During the session, the participants agreed to accommodate the following witnesses’ schedules: David Estrada will testify on September 28, 2015; Douglass Littlefield will testify on either or both September 29 and 30, 2015; and Bob Wagner will testify after October 12, 2015.

The parties have not yet reached an agreement as to the order of other witnesses. To help facilitate scheduling of the expert witnesses, we volunteered to draft an initial proposed schedule of expert witness appearances. From the various expert and percipient witness disclosures and designations as well as from case management conference statements, we estimate that thirty-five individuals have been designated as an expert or combined expert and percipient witness for the upcoming trial.

We understand that some of these witnesses may be offered as rebuttal witnesses, if necessary, and some of these witnesses may have already testified during recent court hearings. For a complete proposed schedule, we include all thirty-five designated individuals and in the following proposed order of appearance:
