2 statement for the Order to Show Cause re Status of Case. The only issue pending before this
3 Court is the Small Pumper Class’ Motion for Modified Attorneys’ Fees Award Consistent with
4 Court of Appeal Opinion (“Motion”). The Small Pumper Class filed the Motion on or about
5 February 28, 2022, before a judge was assigned to hear the matter and did not and could not
6 provide a hearing date for the Motion.


7 On February 24, 2022, Judge Jack Komar, who preceded over the Antelope Valley
8 Groundwater cases, issued an order “remand[ing] to the Los Angeles Superior Court Assistant
9 Supervising Judge for Civil/Complex for re-assignment for hearing(s) limited to the issues
10 specified by the Court of Appeal related to the [sic] to the remanded issues of attorneys’ fees,
11 costs, costs and attorneys’ fees on appeal, and all matters related thereto (such as post-judgment
12 interest and Government Code elections).”

13 Until April 13, 2022 when counsel for the Small Pumper Class served the Notice of Order
14 to Show Cause re Status of Case, District No. 40 was not aware that this matter has been assigned
15 to the Honorable Judge David S. Cunningham. District No. 40 has not been notified of a hearing
16 date for the Motion, and requests that the Court set a hearing date for the Motion.
