

25 On or about September 22, 2011, the Court entered an Amended Final Judgment Approving
26 Willis Class Action Settlement, which, in pertinent part, awarded Judgment for fees and costs on behalf
27 of the Willis Class and against defendants Los Angeles County Waterworks District No. 40, City of

1 Palmdale, Palmdale Water District (“PWD”), Littlerock Creek Irrigation District, Palm Ranch Irrigation
2 District, Quartz Hill Water District, California Water Service Company, Rosamond Community
3 Services District, Phelan Pinon Hills Community Services District, Desert Lake Community Services
4 District, and North Edwards Water District (collectively, “Defendants”) in the total amount of
5 \$2,075,174.18. Pursuant to an agreement between PWD and the Willis Class, PWD has paid its share of
6 that judgment in the amount of \$567,165. The Willis Class covenants and agrees not to seek further
7 monetary relief from PWD in connection with that Amended Judgment and acknowledges that PWD has
8 satisfied its share of that judgment.

10 IT IS HEREBY ACKNOWLEDGED THAT the Amended Final Judgment approving Willis
11 class action settlement, entered on September 22, 2011, in favor of the Willis Class against Defendants
12 has been partially satisfied as to that portion of the monetary judgment for attorneys’ fees, incentive
13 award, costs, and supplemental attorneys’ fees paid by Palmdale Water District, set forth above. This
14 Acknowledgement only releases Defendant Palmdale Water District from the monetary fee award and
15 does not release any party, including Palmdale Water District, from the non-monetary provisions of the
16 Amended Judgment.
