Public Water Supplier / Cross-Defendant West Valley County Water District (“West Valley”) hereby gives Notice of the signature of Public Water Supplier / Cross-Defendant North

1 Edwards Water District (“North Edwards”) on the Addendum to the Agreement between West
2 Valley and those specified Water Suppliers, dated as of March 12, 2015 (“WV/PWS Agreement”),
3 which is identified as Exhibit 4 to the Declaration of Mark Crosby, General Manager of West
4 Valley, filed on September 23, 2015 [SCC E-filing Document No. 10623].

5 West Valley is a stipulating party to the Proposed Judgment and Physical Solution
6 currently pending before the court. [Stipulation for Entry of Judgment and Physical Solution filed
7 March 4, 2015, at signature page 135.] Pursuant to said Stipulation, West Valley will receive an
8 annual pumping allocation of 40 acre feet. As a supplemental source of water, West Valley also
9 entered into the WV/PWS Agreement, whereby the other Public Water Suppliers and West Valley
10 have agreed that West Valley, in addition to receiving Non-Overlying Production Rights, is also
11 authorized to produce up to 35 acre feet annually from any unused Federal Reserve Water Rights
12 Production which may be allocated to the other Public Water Suppliers as described in Section
13 5.1.4.1 of the Proposed Judgment and Physical Solution.

14 At the time of the original preparation of the WV/PWS Agreement, North Edwards was not
15 included as a party because it had not yet reached agreement on the Proposed Judgment and
16 Physical Solution issues, but it has since also signed as a stipulating party.

17 North Edwards has now been added as a party to the WV/PWS Agreement through the
18 Addendum, which the North Edwards Board of Directors approved at its meeting on September
19 21, 2015, and signed by North Edwards’ General Manager Dollie Kostopoulos. West Valley
20 received the executed North Edwards Addendum on September 25, 2015.

21 A true and correct copy of the executed North Edwards Addendum to the WV/PWS
22 Agreement is attached hereto as **Exhibit 1**.


