

1 On March 12, 2007, this Court heard the Petition of Plaintiff Rebecca Willis seeking an
2 Order that the case captioned *Rebecca Lee Willis, on behalf of herself and all others similarly*
3 *situated, Plaintiff, vs. Los Angeles County Waterworks District No. 40, et al; Defendants*, Case No.
4 BC 364 553 (Los Angeles County Superior Court) ("*Willis*") be coordinated with the *Antelope Valley*
5 *Groundwater Cases*, J.C.C.P. No. 4408. After due consideration and it appearing that the *Willis case*
