1 LV Ritter Ranch, LLC is the owner of certain real property overlying the Antelope Valley
2 Groundwater Basin commonly known as the Ritter Ranch property. (A true and correct copy of the
3 Grant Deed for said property was lodged with the Court as Exhibit A to LV Ritter Ranch, LLC's
4 Notice of Lodging of Grant Deed filed on May 15, 2015 in the instant action.) LV Ritter Ranch had
5 previously informed the parties in its Response by Non-Stipulating Party LV Ritter Ranch, LLC to
6 the Proposed Stipulated Judgment and Physical Solution filed on April 8, 2015 that LV Ritter Ranch
7 did not object to the Proposed Stipulated Judgment and Physical Solution, even though LV Ritter


