DECLARATION OF TAKING

TO THE HONORABLE, THE UNITED STATES DISTRICT COURT

I, the undersigned, James H. Douglas, Major

Secretary of the Air Force of the United States of America, do hereby
make the following declaration by direction of the Secretary of the
Air Force:

1. (a) The lands hereinafter described are taken under and in
accordance with the Act of Congress approved February 25, 1931 (47 Stat.
1471, 20 U.S.C. 515a) and acts supplementary thereto and amendatory
thereof, and under the further authority of the Act of Congress approved
August 1, 1930 (46 Stat. 247, 40 U.S.C. 257); the Act of Congress
approved August 18, 1930 (46 Stat. 518) as amended by the Act of
Congress approved July 2, 1917 (40 Stat. 541) and April 11, 1918
(40 Stat. 549, 40 U.S.C. 191), which acts authorized the acquisition of
land for military purposes; the Act of Congress approved August 12, 1928
(46 Stat. 610, 611); 40 U.S.C. 192a, b and c, said Act authorized the

1 acquisition of land for Air Force Stations and Depots; the National
2 Security Act of 1947 approved July 26, 1947 (51 Stat. 495); the Acts of
3 Congress approved June 17, 1949 and January 6, 1951 (Public Law 504
4 and 511, 81st Congress) and the Act of Congress approved September 22,
5 1951 (Public Law 108, 82nd Congress), which acts authorize acquisition
6 of the land, and the acts of Congress approved September 6, 1950 and
7 January 2, 1951 (Public Laws 758 and 511, 81st Congress) and the Act
8 of Congress approved November 1, 1951 (Public Law 244, 82nd Congress),
9 which acts appropriated funds for such purposes.

10 (b) The public uses for which said lands are taken are as
11 follows: The said lands are necessary, adequately, to provide for
12 expanding needs and requirements for the Department of the Air Force
13 and other military uses incident thereto. The lands have been selected
14 under the direction of the Secretary of the Air Force for acquisition
15 by the United States for use in connection with Edwards Air Force Base,
16 California, and for such other uses as may be authorized by Congress
17 or by Executive Order.

18 c. A general description of the lands being taken is set forth in
19 Schedule "A", attached hereto and made a part hereof, and is a descrip-
20 tion of the lands described in the Complaint in Condominium filed in
21 the above-captioned cause.

22 d. The estate hereby taken for said public uses is the fee simple
23 title, subject, however, to existing easements for public roads and
24 highways, public utilities, railroads and pipelines.

25 e. Plans showing the lands taken are annexed hereto as Schedule "B"
26 and made a part hereof.

27 f. The sum contracted by the undersigned as full consideration for
28 the said lands, with all buildings and improvements thereon and all
29 appurtenances thereto and including any and all interests hereby taken
30 in said lands is set forth in Schedule "C" herein, which are the under-
31 signed names to be deposited herewith in the registry of the Court
32 for the use and benefit of the persons entitled thereto. The enter-
