1 IT IS HEREBY ORDERED that the motion is granted with the following modification to
2 the definition of the Class. The Class shall be defined as:

3 "All private (i.e., non-governmental) persons and entities that own real
4 property within the Basin, as adjudicated, and that are not presently pumping
5 on their property and have not done so within the five year period preceding the
6 filing of this action. The Class excludes the defendants herein, any person,
7 firm, trust, corporation, or other entity in which any defendant has a controlling
8 interest or which is related to or affiliated with any of the defendants, and the
9 representatives, heirs, affiliates, successors-in-interest or assigns of any such
10 excluded party. The Class also excludes all persons to the extent their
11 properties are connected to a municipal water system, public utility, or mutual
12 water company from which they receive water service."

13 The Second Amended Class Action Complaint was posted on May 6, 2008 and it shall be
14 deemed filed as of that date.
