The United States hereby supplements its Expert Witness Declarations of Dr. June
Oberdorfer. Pursuant to California *Code of Civil Procedure* § 2034.260(c)(2), the United States
supplements its previously filed brief narrative statement of the general substance of the

1 testimony of Dr. Oberdorfer with the following.


2 Dr. Oberdorfer may testify as a rebuttal witness regarding the hydrologic connection
3 between the alleged Anaverde Creek basin and the remainder of the Antelope Valley
4 Adjudication Area ("AVAA"). Based upon her review of Dr. Lambie's report, deposition
5 testimony, trial testimony, and available hydrologic, geological and ground water information
6 regarding the alleged Anaverde Creek basin, Dr. Oberdorfer will opine that 1) Dr. Lambie
7 appears to have overestimated recharge and evapotranspiration discharge within the Anaverde
8 Creek watershed; 2) Dr. Lambie may be underestimating the amount of water discharging from
9 the alleged Anaverde Creek basin into the broader Antelope Valley aquifer, and 3) the surface
10 and ground water system within the alleged Anaverde Creek basin are in hydrologic connection,
11 and share a common source of supply, with the AVAA. In addition, she may also testify
12 regarding her estimation of the amount of ground water leaving the Anaverde Creek drainage that
13 discharges into the larger Antelope Valley ground water system.

14 Dr. Oberdorfer is sufficiently familiar with this pending action to submit to a meaningful
15 oral deposition concerning the matters described above.

16 I declare under the penalty of perjury, the above statements are true and correct.
