Sundale has two pumping zones which operate independently of each other. Zone A contains well #1 and #3 which are both located on 70th Street West and West Avenue A-12. Zone B contains well #2 and #4 which are both located on 85th Street West and West Avenue C-8. The computation below is an analysis of the year 2008 which uses the hour meters, GPM capacity (Information obtained from the most current SCE hydraulic sheet taken from an 11-30-07 report – copy attached), gallons per acre feet, and total kilowatt usage for year 2008 to compute the average KW/AF for each zone. This is necessary because Sundale did not record the daily well usage until August 2007.

1. Pump Test of 11-30-07 *Pg 3*

Each of the four wells had a GPM capacity and wells #1, #3, & #4 are used in the analysis. Well #2 had an internal operating problem (which was later repaired and brought back to proper operating efficiency) in 2007. We therefore used the test results of 428 GPM from December 2006. This was felt to be more representative of the test period. (*See Pg -7*)

2. Total Hours Wells Ran in 2008 *Pg 2*

The four well logs were listed for the start of 1-1-2008 and end date of 1-1-2009 and the differences were the hours each well ran for each year.

3. Computed Total Minutes Per Year Per Well *Pg 2*

The total hours per year per well is then multiplied by 60 to reach the minutes per year per well.

4. Computed Gallons Per Year Per Zone *Pg 2*

The total minutes per well is multiplied by the applicable GPM capacity per well found in the SCE hydraulic sheet. This results in the total gallons per well per year. The gallons for wells #1 and #3 are combined to display total gallons in Zone A. The gallons for wells #2 and #4 are combined to reach the total gallons in zone B.

5. Computed the Total Acre Feet Per Zone *Pg 2*

The total gallons per zone is then divided by the gallons in an area foot (325,829) to reach the total acre feet pumped per zone.

6. Computed the Average Kilowatts Per Acre Foot Per Zone *Pg 2*

The total kilowatts used for the year per zone are divided by the total acre feet per zone to compute the average kilowatts per acre feet for each zone.

7. Compute the Total Acre Feet Used Per Year Per Zone *Pg 6*

For each year requested (2000, 2001, 2002, 2003 & 2004), the total kilowatts per year per zone is divided by the computed average kilowatts per year to reach the acre feet per zone.

8. Compute the Total Acre Feet Used Per Year *Pg 6*

The total acre feet for each zone are combined resulting in the total acre feet for each requested year.
