Re: Summary of January 29, 2016 Overlyers' Conference Call Regarding Process for Selection of Landowner Parties

Dear Parties & Counsel:

A telephonic conference of Landowner Parties and their counsel was held on Friday, January 29th at 1:30 p.m., to discuss the selection of the two (2) Landowner Parties' representatives on the Watermaster Board. The following individuals were on the call: Carlos Ambriz, Mark Beuhler, Karen Bilotti, Sheldon Blum, Andrew Brady, Ted Chester, Lori Clifton, Michael Davis, Michael Fife, Noah Golden-Krasner, Bob Joyce, Robert Kuhs, Lee McElhaney, Daniel O'Leary, Stan Powell, Chris Sanders, William Sloan, Scott Kuney, John Ukkestad and Richard Zimmer. Though Karen Bilotti and Lori Clifton were on the call, Ms. Bilotti stated that the Robar Parties have not yet determined what action they will take, if any, respecting their Section 5.1.10 Production Rights.

The following is a summary of the topics of discussion as to which there was apparent consensus (with agreed changes indicated as strikeout or redline), and the topics as to which further discussion will be required.

<u>Duration</u>: The following language was conceptually agreed to by consensus.

"These procedures and process shall apply to the initial selection of the two (2) Landowner Parties' representatives on the Watermaster Board, only. Nothing agreed to comprise these initial procedures and process shall be precedent for or binding on the Stipulating Parties except for the initial selections."

<u>Notices</u>: The following language was conceptually agreed to by consensus.

"All notifications for any aspect of the process of selecting the two (2) Landowner Parties' representatives on the Watermaster Board shall be transmitted by email, to the addresses of the Landowner Parties'

designated representatives, and their attorneys if they are of record, and by posting on the Court's website. The initial email list for such notifications shall be that list, a copy of which is attached, that was compiled by the U.S. DOJ. Corrections and additions to the initial email list shall be transmitted to the Inspector of Elections, along with verification therefor. Postings shall not be directed and email notifications shall not be transmitted to non-Parties or Parties not entitled to vote for the two (2) Landowner Parties' representatives under Section 18.1.1 of the Judgment. All notices shall be transmitted and posted at the earliest practical time, and at least three (3) court days in advance of any event or deadline for action."

Inspector of Elections: The following language was conceptually agreed to by consensus.

"James Dubois of the United States Department of Justice [James.Dubois @usdoj.gov] is designated and has agreed to serve as the initial Inspector of Elections. Emails directed to the Inspector of Elections shall contain the applicable subject line of 'Inspector of Elections – Nominations' or 'Inspector of Elections – Ballots' or 'Inspector of Elections – Challenges.' Once established, the Watermaster shall succeed the initial Inspector of Elections. Pending the establishment of the Watermaster, Mr. Dubois may designate a successor Inspector of Elections, which designation shall become effective upon seven (7) days' notice given in accordance with the foregoing provisions unless, within that time, greater than fifty percent (≥50%) of the eligible votes are cast against that designee."

Landowner Seats: The following language will require further discussion.

"One of the two (2) Landowner Parties' seats on the Watermaster Board shall represent the interests of the Landowners Parties holding Production Rights in excess of 1000 acre feet, and the other of the two (2) Landowner Parties' seat shall represent the interests of the Landowner Parties holding Production Rights of 1000 acre feet or less."

Nominations: The following language was conceptually agreed to by consensus.

"Any Party entitled to vote for the two (2) Landowner Parties' representatives under Section 18.1.1 of the Judgment, shall be entitled to nominate an individual for either or both of the two (2) Landowner Parties' seats on the Watermaster Board. Nominees must be natural individuals, and not unnamed representatives of an entity named on Exhibit 4. Nominations shall be made by posting the nomination on the Court's website or by email to all parties on the then most current email list. Nominations shall commence not less than thirty (30) days from the date on which the "opening" of nominations is posted to the Court's website by the Inspector of Elections, and shall will remain open for a period of not less than seven (7) days from the "opening date" posted on the Court website by the Inspector of Elections USDOJ, which posting shall also designate the date and time that nominations will be deemed closed. A brief statement of qualifications that discloses the candidate's official capacity with an Exhibit 4 Stipulating Party must accompany the nomination.

Ballots: The following language was conceptually agreed to by consensus.

Within five (5) days of the close of nominations, the Inspector of Elections shall post the Ballot on the Court website and transmit the same by email to the parties and/or their attorneys as designated on the attached email list. The Ballot shall state the deadline for receipt of the cast ballot by the Inspector of Elections, and shall be accompanied by a Statement of Qualification for each nominee. Ballots shall be cast confidentially, and transmitted by email to the Inspector of Elections. The Inspector of Elections shall report the results of the election by posting the names of the two (2) Nominees receiving the highest number of votes to the Court's website.

Voting Rights: The following language was conceptually agreed to by consensus.

Each voting Party on Exhibit 4 to the Judgment shall have one (1) vote for each acre foot of water set forth in the Overlying Production Rights column. Commonly held Exhibit 4 rights such as that held by "Diamond Farming Co. LLC/Crystal Organic LLC/Grimmway/Lapis" shall be deemed a single Overlying Production Right exercisable by the common ownership. The voting right shall be exactly as reflected on Exhibit 4, including that reflected as tenths or hundredths of an acre

foot rounded to the nearest acre foot. Only those Overlying Parties on Exhibit 4 shall be entitled to cast votes for the two (2) Landowner Parties' representatives on the Watermaster Board.

<u>Challenges</u>: The following language was conceptually agreed to by consensus.

Any Party may contest any action taken respecting the adoption or modification of these procedures, or any action taken under these procedures as adopted, to the Inspector of Elections and to the Court.

The undersigned agreed to prepare and post these minutes of the January 29th conference call. A further conference call will be scheduled to continue the discussion, including that of any items not agreed to by the Exhibit 4 Stipulating Parties who participated in the conference call.
