December 8, 2020 ("Order"), the Court has scheduled the above-captioned telephonic evidentiary hearing to "prove-up" the proposed resolution of the Production Right claim of Intervenor SCI CALIFORNIA FUNERAL SERVICES, INC., A CALIFORNIA CORPORATION DBA JOSHUA MEMORIAL PARK AND MORTUARY ("Joshua Memorial"), pursuant to Paragraph 5.1.10 of the December 23, 2015 Judgment and Physical Solution.

In accordance with the Order, Joshua Memorial timely filed and served its Prove-Up package, including a written brief, declarations in lieu of live testimony and related supporting evidence, together with an executed stipulation for admission of evidence in support of Joshua Memorial's Production Right claim (among all parties previously opposed to the claim), and a proposed order.
