Dear Counsel:

As you are all aware, the Judgment in this matter was entered on December 28, 2015 and Notice of Entry was served on December 28, 2015.

As you are all aware, Well 14 supplies approximately one-third of Phelan Piñon Hills Community Services District's water supply. In light of the District's status as a municipal water supplier, the public health and safety of its customers would be negatively impacted if the District were to cease pumping from Well 14 and refrain from participating in post-judgment proceedings and Watermaster meetings. Accordingly, we write to inform all parties that the District's participation in any post-judgment proceedings, Watermaster meetings, or its activity of pumping water from the Antelope Valley Adjudication Area, among other activities, is not intended as, and shall not be deemed to be, a waiver of its right to appeal the Judgment.
