I am told that Waterworks District 40 investigated the APNs you provided. They came up with the following:

Here is a summary for Rosamond Ranch:

Their claim:

- Size: 730 acres

Pumping: 4380 AFY

- Crops: alfalfa, onions, carrots, and pistachios

Our findings:

- Size: 670 acres (Kern County Assessor's website)
- Pumping: 3565 AF for 599 acres in 00; 2001 AF for 308 acres in 01; 1988 AF for 306 acres in 02; 1936 AF for 298 acres in 03; 1927 AF for 296 acres in 04; and average of 2283 AFY (Kern County ag. permits)
- Mostly alfalfa and some barley in 00. (Kern County ag. permits)

Accordingly, we will be using 2283 acre-feet per year as the "verified production" on our spreadsheets.

As we also discussed, I have had further discussions with the former farmer on our subject property, Scott Harter, and have thus revised and supplemented our prior information disclosure, as well obtained a figure for actual irrigated land; the information provided, also provided to the court in my response to the OSC hearing filed yesterday, is as follows:

Crops -Crops grown were primarily alfalfa (320 acres over several years); carrots and onions (80

Purchased from: COALINGA CORPORATION, a Nevada corporation, on August, 9, 2004

ESTIMATED Approximate Water Usage/Pumping/Rights (farming)

4000 gallons/minute (approx); 8 months per year

Converted to acre feet: 6,500 acre/foot per year.

**However, during mediation settlement negotiations respondent's have consented and stipulated to a lower water useage for purposes of settlement

of matter.

LOCATION- throughout property on above APN numbers

TIME FRAME- Late 2004- 2008-9
