2 TO ALL PARTIES AND TO THEIR ATTORNEYS OF RECORD:

3 CROSS-DEFENDANT, WDS CALIFORNIA II, LLC ("WDS"), hereby provides the
4 following responses pursuant to the Discovery Order for Phase 4 Trial dated, December 12, 2012.

5 **GENERAL RESPONSE AND OBJECTIONS**

6 Cross-Defendant WDS has not fully completed its investigation of the facts relating to
7 this case, has not completed discovery in this action, and has not completed preparation for
8 trial. All of the responses contained herein are specifically known to WDS and WDS discloses
