3 TO ALL PARTIES AND TO THEIR ATTORNEYS OF RECORD:

4 Defendants, DELMAR D. VAN DAM, GERTRUDE J. VAN DAM, and GARY VAN
5 DAM (collectively, "VAN DAMS"), hereby provide the following responses pursuant to the
6 Discovery Order for Phase 4 Trial dated, December 12, 2012.

7 **GENERAL RESPONSE AND OBJECTIONS**

8 VAN DAMS have not fully completed its investigation of the facts relating to this case,
9 has not completed discovery in this action, and have not completed preparation for trial. All of
10 the responses contained herein are specifically known to VAN DAMS and discloses only those
11 contentions which presently occur to VAN DAMS.

12 It is anticipated that further discovery, independent investigation, legal research, and
13 analysis will supply additional facts, add meaning to the known facts, as well as establish
14 entirely new factual conclusions and legal contentions, all of which may lead to substantial
15 additions to, changes in, and variations from the contentions herein set forth.

16 The following responses are given without prejudice to VAN DAMS's right to produce
17 evidence of subsequently discovered fact or facts which VAN DAMS may later recall. VAN
18 DAMS accordingly reserves the right to change any and all answers herein as additional facts
19 are ascertained, analyses are made, legal research is completed and contentions are made. The
20 answers contained herein are made in a good faith effort to supply as much factual information
21 and as much specification of legal contentions as are presently known, but should in no way be
22 to the prejudice of VAN DAMS in relation to further discovery, research or analysis.

23 Furthermore, to the extent that any of these questions violates the attorney-client
24 privilege, the attorney work product doctrine and the constitutional right to privacy, VAN
25 DAMS refuses to answer and hereby asserts these privileges and protections.

These responses have been prepared by VAN DAMS in a good faith effort to supply as much factual information and as much specification as possible given the time requirements but VAN DAMS reserve the right to change and supplement its answers as additional facts are ascertained and analyses are made.

REQUEST 1.(K)a:

State the amount of water rights claimed as the reasonable and beneficial use for each such parcel.

RESPONSE TO REQUEST 1.(K)a:

VAN DAM asserts to the fullest extent provided by law a prior and paramount overlying water right to any native groundwater existing in the aquifer underlying the real property it owns, occupies or otherwise controls. (*Katz v. Walkinshaw* (1903) 141 Cal. 116, 135-136; *City of Barstow v. Mojave Water Agency* (2000) 23 Cal. 4th 1224, 1240-41). VAN DAM claims the maximum amount of groundwater capable of being pumped from the native groundwater supply underlying the real property identified in these Responses for any past, present or future reasonable beneficial use to the fullest extent authorized by the California Constitution, Article X, Section 2 and other applicable law.

For example, but without any limitation whatsoever, such maximum amount (annually) in consideration of all the years referenced in the Court Ordered Discovery (2000-2004, 2011 and 2012) is shown in Table 1 below and amounts to 10,685 acre-feet per year.

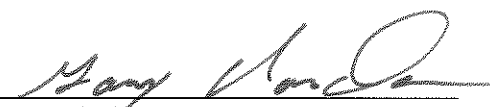
