I, Robert E. Dougherty, declare:

1. I am an attorney at law, duly licensed to practice before all the courts of the
State of California, and am a partner in the law firm of Covington & Crowe, LLP,
counsel for Defendant/Cross-Complainant White Fence Farms Mutual Water Co. Inc. in

1 this action.

2 2. The following facts and circumstances are within my own personal
3 knowledge and belief, and if called upon to testify I could and would testify competently
4 and accurately regarding same.

5 3. Attached as Exhibit A hereto is a true and correct copy of the Los Angeles
6 County Assessor's property owner mailing information pertaining to eighty-three (83)
7 separate parcels located within a one square mile area in the Antelope Valley, bounded
8 by 110th Street West to 120th Street West on the east and west and West Avenue H and
9 West Avenue I on the north and south.

10 4. As can be seen from this sampling, the mailing addresses of the property
11 owners show that only five owners, or 6%, live in the Antelope Valley. Another 22
12 owners, or 26%, live in Los Angeles County. There are 24 owners, 29%, who live in
13 California counties other than Los Angeles. The largest group of owners, which number
14 30, or 36%, live outside the State of California. In two instances, the property owners
15 live outside this country.

16 5. A published notice in a local Antelope Valley newspaper, or even the Los
17 Angeles Times newspaper, would probably exclude notice to 68% of these property
18 owners. The property owners' addresses can be readily ascertained through the local
19 County Assessor's office.

20 6. As most property owners would likely never receive notice of this litigation
21 through notice by publication, White Fence Farms Mutual Water Co. Inc. respectfully
22 requests that notice to all property owners be made by first class mailing.

23 I declare under penalty of perjury under the laws of the State of California that the
24 foregoing is true and correct.
