Ladies and Gentlemen:

As most of you know, the Superior Court of the State of California in and for the County of Santa Clara has graciously hosted www.scefiling.org and info@glotrans.com to assist with the electronic filing and service requirements of the Antelope Valley Groundwater Adjudication cases, consolidated under JCCP 4408. That service ended on June 30, 2016. Though new systems are going into effect, we are all presently conducting business under a quite imperfect and frustrating set of circumstances.

Over the past few days, a number of our (and other) office staffs have spent hours on the phone with various officials at the Santa Clara and Los Angeles County Clerks Offices, and representatives of OneLegal and TrueFiling, which are some of the services that are replacing info@glotrans.com. What has become apparent is that there are multiple service lists, most (if not all) of which, contain errors and omissions, including in the identification of representatives, firm names, addresses, phone numbers and email addresses of the representatives and legal counsel for the parties of record. Further, the services lists that have been transmitted to the Court of Appeals are also flawed and have been supplemented by the Court(s) in an attempt to make them more complete and accurate. We have also learned that only the appellants' offices have the ability to correct the appeals service lists (except that the Clerk's Offices have the ability to correct the "Court Added" information).
