## [PROFOSED] ORDER

On February 17, 2017 the Court held a hearing in Department 222 of the above-entitled Court, the Honorable Jack Komar, Judge, presiding, on FS Land Holding Company, LLC's Motion for Leave to Intervene in the Judgment in the above-captioned action.

The Court, having reviewed FS Land Holding Company, LLC's Motion for Leave to Intervene in the Judgment and attached memorandum of points and authorities, the concurrently-filed Declaration of Kevin Peters, the Stipulation in Support of FS Land Holding Company, LLC's Intervention in Judgment ("Stipulation"), executed by FS Land Holding Company, LLC and the Antelope Valley Watermaster, and having heard argument, and there being no objection and good cause appearing, hereby ORDERS as follows:

- Pursuant to Section 20.9 of the December 23, 2015 Judgment and Physical Solution, FS
  Land Holding Company, LLC is hereby granted leave to intervene in the Judgment and
  Physical Solution in the above-captioned action.
- 2. The Stipulation is approved, authorizing the transfer of water rights to FS Land Holding Company, LLC as successor in interest to the following rights allocated in Exhibit 4 to the December 23, 2015 Judgment and Physical Solution:
  - a. 736.44 AFY of Landiny, Inc.'s total 969.00 AFY of Overlying Production Rights (1,520 AFY of Landiny, Inc.'s total 2,000 AFY of Pre-Rampdown Production).
- 3. FS Land Holding Company, LLC is authorized to produce groundwater from the Antelope Valley Area of Adjudication, subject to FS Land Holding Company, LLC's compliance with the requirements set forth in the December 23, 2015 Judgment and Physical Solution.
