7 **ORDER MODIFYING CLASS DEFINITION**

8 The Proposed Order Modifying Class Definition and Allowing Parties to Opt In to the  
9 Plaintiff Class, submitted by Plaintiff Willis on or about May 20, 2008, is modified by the  
10 Court to reflect the date of August 15, 2008 on page 4, lines 3-5, and shall now read as follows:  
11 “On or before Aug. 15, 2008, L.A. County Waterworks District No. 40 shall compile a list of  
12 Class Members and propose a means for disseminating the Class Notice to such persons, which  
13 it shall post on the case website.” Said order shall be signed by the Court and posted to the  
14 website as soon as possible.

16 **SMALL PUMPERS CLASS COMPLAINT AND RESPONSES THERETO**

17 Counsel representing the small pumpers class shall file its Complaint (“Small Pumpers  
18 Class Complaint”) no later than **June 2, 2008**. Prior answers of parties shall be deemed to be  
19 responsive to the Small Pumpers Class Complaint unless a defendant in the case filed another  
20 responsive pleading; oppositions, if any, shall be due by noon on **June 20, 2008**.

22 **MOTIONS TO CERTIFY THE SMALL PUMPERS CLASS**

23 Moving papers for the Motion to Certify the Small Pumpers Class shall be filed no later  
24 than **June 20, 2008**; oppositions shall be filed no later than **July 11, 2008**; hearing is set for  
25 **August 11, 2008 at 9:00 a.m. in Department 1, Los Angeles County Superior Court**. A  
26 Case Management Conference will immediately follow.
