AMENDED MINUTE ORDER:

Motion by H&N Development Co. West, Inc. ("H&N") to Set Aside Default

Matter was argued and heard. H&N's request for judicial notice is granted, as requested. H&N's motion to set aside the default is granted; H&N's answer shall be filed as soon as possible.

Motion by Antelope Valley Ground Water Agreement Association ("AGWA") for Protective Order (to stay all pretrial discovery); Joinder to same by Landinv, Inc.; Joinder to same by Holliday, Rock Co., Inc.

Matter was argued and heard. The Court ordered the parties to meet and confer regarding the construction of form discovery; the Court took a 20-minute recess to complete this process. The Court resumed session at approximately 10:26 a.m. Mr. Dunn and Mr. Zimmer reported on the status (no agreement was reached).

Following further discussion with counsel, the Court ordered that the parties provide statements of current pumping (up to 2012), and average annual pumping (since 2000). The statements may include, but shall not be limited to, such information as type of pumping, sources of pumping, water uses, how long the pumping has occurred, claims of prescription, return flow, location of property where the pumping occurs/occurred. The statements shall be under penalty of perjury.

Based on the ongoing settlement negotiations, the Court grants the motion by AGWA for protective order, but only until November 9, 2012, subject to further Order of the Court. The motion shall otherwise be continued to **November 9, 2012 at 9:00 a.m. in Department 1.** A proposed order shall be prepared and submitted by Attorney Michael Fife.

Case Management Conference (including setting hearing date on Default/Prove-Up/Trial)

The Court will soon appoint an expert to provide information on the pumping by the Wood Class. The cost of this expert will be shared by the parties in a manner to be later determined by the Court.

The next phase of trial remains for **February 11, 2013 at 9:00 a.m. in Department 1, Room 534.**

A Further Case Management Conference is set for **November 9, 2012 at 9:00 a.m. in Department 1.** Updated statements shall be submitted by November 5, 2012.

Mr. Lemieux requests that the Court set a hearing for a Motion for Preliminary Injunction. The Court set this motion for **November 13, 2012 at 9:00 a.m. in Department 1.**
