MINUTE ORDER: **FURTHER CASE MANAGEMENT CONFERENCE**

The Court discussed the following items:

Quartz Hill Water District's (Attorney Brad Weeks) Opposition to "AGWA" (Attorney Michael Fife) Proposed Third Amendment to Case Management Order for Phase Four Trial. The Court advised counsel it will **not** modify the Third Amendment to Case Management Order for Phase Four Trial (signed March 7, 2013).

Attorney Scott Kuney's concern regarding cropping, meter records, etc. was responded to by Attorney Brad Weeks. The Court offered its comments and reiterated its requirement to meet and confer on issues and failure to do so is in violation of the Court's order; parties are to report back on March 25, 2013 if the issues remain unresolved.

Attorney Ryan Bezzerra's request to extend the deadline to file stipulations from March 15, 2013 to March 20, 2013 is denied. The Court advised that, although it will not extend the deadline to file stipulations, the parties can enter into a stipulation at any time, but that stipulating parties should be mindful of the time for contrary parties, if any, to prepare their objections for the hearing on March 25, 2013.

Attorney William Sloan's request to appear by phone at March 25, 2013 hearing is approved. Mr. Sloan will not have stipulations to present, nor has raised any objections to stipulations filed to date.

Attorney Noah Golden-Krasner confirmed with the Court that on March 25, if there are no objections to stipulations, then stipulations are deemed approved.

Attorney Frank Satalino expressed his concerns over the general objections being filed by certain parties. The Court will address these general objections at the hearing on March 25, 2013.

The Court confirmed that the March 25, 2013 hearing will take place in Department 1 - Los Angeles and will commence at 9am. The Clerk will confirm the location and will notify all parties and counsel immediately if the location should change.

A reminder was made by the Court to all counsel of the May 13, 2013 hearing on motions in limine on the federal reserved rights and/or return flows (see "Future Events" below).
