**ORDER APPROVING TRANSFER OF  
PRODUCTION RIGHT AND TO BE  
CLASSIFIED AS A STIPULATING  
PARTY**

1 On February 17, 2023, the Court held a hearing by Courtcall, the Honorable Jack Komar,  
2 judge presiding, on a motion by CARUSO INVESTMENTS, LLC, a California limited liability  
3 company, for Order Approving Transfer of Production Right and To Be Classified as a Stipulating  
4 Party. Appearances are shown in the Court record. Due cause being shown and having  
5 considered the objections, if any, the Court orders as follows:

6 The transfer of 1,332 acre-feet of Overlying Production Right from Calandri Water  
7 Company, LLC, a California limited liability; John A. Calandri as trustee of the John and Shannon  
8 Calandri 1992 Trust; and Katherine J. Calandri Nelson, Trustee of the Katherine J. Calandri  
9 Nelson 2008 Trust to CARUSO INVESTMENTS, LLC, a California limited liability company is  
10 approved; and CARUSO INVESTMENTS, LLC, a California limited liability company shall be  
11 included as an Exhibit 4 Stipulating Party as to 1,332 acre-feet of Overlying Production Right,  
12 with such transferred water to be recorded in the records of the Watermaster Engineer.
