DECLARATION OF DR. JOHN WILSON

I, John Wilson, do hereby declare and state as follows:

1. I have reviewed the *Declaration of Joseph Scalmanini Re Rebuttal Testimony*, with particular focus on that part of the Declaration regarding my testimony.

2. Mr. Scalmanini discussed my testimony and the results of my analysis of mountain front recharge, however, he did not criticize the methodology I used nor any technical aspects of the analysis.

3. Mr. Scalmanini's sole comment concerning the results of my analysis was to use my nominal estimate of 163,000 AF/Y as the basis for a safe yield calculation. His only criticism consists of the assertion that a safe yield based upon my nominal estimate "greatly differs" from his own. (Declaration, page 14, line 17.)

4. Given that Mr. Scalmanini did not provide any direct criticism of my mountain front recharge analysis, my testimony remains as provided and there is nothing in Mr. Scalmanini's declaration that calls for my "surrebuttal."


