
1 TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:

2 The Antelope Valley Groundwater Agreement Association ("AGWA") hereby joins in the
3 Case Management Conference Statement filed by Bolthouse Properties, LLC and Wm. Bolthouse
4 Farms, Inc., on September 14, 2011.

5 AGWA also hereby objects to the Antelope Valley-East Kern Water Agency's ("AVEK")
6 Case Management Statement filed September 30, 2011, to the extent that it proposes a trial be
7 scheduled for January of 2012. (AVEK's Case Management Statement, filed September 30, 2011, at
8 ¶¶ 1, 4.) As was learned from the process leading up to the Phase III trial, scheduling a trial in this
9 case does not facilitate settlement discussions, it derails them. Given the continued progress of the
10 ongoing mediation process before Justice Robie, scheduling a preliminary trial date for January of
11 2012 is premature at this time.
