Phase 4 trial set for February 11, 2013;
2. The attached Declaration may be used in the same manner at trial as a deposition
transcript executed under penalty of perjury by <u>Lawrence J. Schilling</u> .
3. The Public Water Suppliers reserve the right to depose <u>Lawrence J. Schilling</u>
during discovery for subsequent trial phases or in the event the Court continues the Phase 4 trial
to a date other than February 11, 2013; and
4. The Public Water Suppliers reserve their right to challenge the testimony of _
Lawrence J. Schilling at trial.
