Dear Mr. Brumfield:

Attached to this cover letter is the substitution of attorney form which you requested I sign in order to confirm your representation of Mark Ritter in the Antelope Valley adjudication. As you are aware, this is a unique situation and it is not clear that the filing of a substitution of attorney is necessary or appropriate. As a courtesy to you, we are signing the form you have provided, but believe it is important that such action be accompanied by an explanation of context. The purpose of this cover letter is to provide such context and is a component of our execution of the substitution of attorney form.

Sometime in 2005, the Ritters approached me about joining the group of defendants that my firm represents in the Antelope Valley adjudication. There are approximately 40 individuals in this group of defendants. The Ritters indicated an intention to join the group and were included within the group on our masthead based on their representation that they would join the group. Subsequently however, they refused to sign any of the necessary representation documents such as the fee agreement and conflict waiver for the group. They represented that they did not want to be a part of this group of defendants and did not want to be represented by my firm in the adjudication.

No attorney client relationship between my firm and the Ritters was ever formed. Neither I, nor anyone else at my firm ever investigated nor received any information about the Ritter's property or water use. Subsequent to their decision not to join our group of defendants neither I, nor anyone else at my firm, had any contact with them. They were never billed for any services.

On September 3, 2015 you filed a case management statement and indicated that you had accepted representation of Mark Ritter. Your case management statement requested that I sign a substitution of attorney form, and you repeated that request at the subsequent court hearing. At that hearing I indicated to the Court that I was willing to sign such a form. You have provided the present form pursuant to that request.

To be clear, while my signature on the form is made as of the date indicated, you have represented Mr. Ritter since at least the summer of 2015, and no attorney-client relationship has ever existed as between my firm and Mark Ritter, his parents, or his trust. Your firm is fully capable of representing the Ritter interests in this phase of trial, as you are doing for your other client who is similarly situated. This phase of trial is the first at which individual interests have been at issue, and whatever confusion may have existed in the past has been without prejudice to the Ritter interests.
