On September 8, 2023, the Court held a hearing by Courtcall, the Honorable Jack Komar, judge presiding, on a motion by Craig Van Dam (“**Craig**”) in the above captioned action for an order approving his application to transfer 500 acre-feet of permanent production water rights from High Desert Dairy, LLC (“**HDD**”) to Craig (the “**Motion**”).

Appearances are as shown in the Court record. Due cause being shown and having considered the objections, if any, the Court orders as follows:

1. An evidentiary hearing on the Motion is set for December 4, 5 and 6, 2023, in Santa Clara Superior Court pursuant to Paragraph 20.3.4 of the Judgment (the “**Hearing**”).

1           2.       The Court will allow for the Hearing to occur on additional days if necessary, which  
2 will be determined during the course of the Hearing at the discretion of the Court.

3           3.       Appearances at the Hearing are to be in-person for presentation of live testimony  
4 and evidence to address (a) whether HDD and Craig have the legal authority to enter into the  
5 proposed transfer of permanent production water rights given the relevant law and facts, and (b)  
6 any other factual and legal issues relevant to the merits of the Motion.

7           4.       Craig, Gary Van Dam and any other Parties who intend to participate in the Hearing  
8 shall meet and confer in an effort to stipulate to the process, procedures and timelines for discovery,  
9 briefing and mediation or settlement conference relative to the Hearing.
