7 authorized to produce groundwater from the Antelope Valley Adjudicated Area, subject to
8 compliance with the requirements set forth in the Judgment, and as the transfer request of Steven
9 Selak as Trustee of the Christine and Steven Selak Trust was approved by the Board of Directors
10 of the Antelope Valley Watermaster on July 25, 2018 pursuant to Resolution No. R-18-24.


