I, PETER TUCULET, declare as follows:

- I am the General Manager of PALM RANCH IRRIGATION DISTRICT (herein "District"), a public water purveyor. I am authorized to make this declaration on behalf of the District.
 I have worked for the District, a public agency, since 1997.
- 2. I have personal knowledge of the facts set forth herein, and if called to testify, I could and would competently testify thereto. As General Manager and a long-time employee of the District, I am familiar with the practices and management of the District, including but not limited to the record-keeping practices of District, the number of connections, type of water use by customers (for example, domestic, irrigation or commercial), the District budget and amount in reserve, and the amount expended by the District on attorneys' fees.
- 3. There are currently1,672 connections that receive water service from the District. Of these, approximately 1,637 are households with the remainder being commercial or irrigation use. The District has an annual operating budget of \$771,729. The District has \$1,037,145.28 in reserve for fiscal year 2014-2015. The District has only 3 employees.
- 4. Throughout the 15 years of this litigation, the District spent a total of \$426,213.69 in attorneys' fees. They were billed at billing rates from between \$170 through \$400 per hour, the average being \$291 per hour. The District did not have the financial means to pay for legal fees at a higher rate. If the amount paid as legal fees is broken down by connection, each customer of the District has already paid approximately \$254.91 in defending this litigation. In addition, the District expects it will continue to incur legal fees as it defends this matter through appeal, as well as in connection with the formation and operation of the Watermaster.
- 5. As a public agency, the District cannot operate at a profit but is permitted to have a reserve fund. If the amount requested by the Wood Class were awarded against the District, this would greatly exceed the operating budget and reserve fund, and therefore, the District would have insufficient funds to continue to operate and provide water to the community.

6. State-mandated drought measures have resulted in a serious burden on the revenue of the District. Due to our limited budget and staff, I have had to do field work, in addition to my General Manager duties, because we do not have sufficient funds to hire more staff. The District has had to lay off staff. The Districts has begun to draw down on its own financial reserve in order to cover its basic expenses.

I declare under penalty of perjury under the laws of the state of California that the foregoing is true and correct.
