BOLTHOUSE FARMS, INC., (hereinafter Bolthouse), hereby join AGWA'S Objection to Second Amended (Proposed) District 40 Proposed Statement of Partial Decision for Phase IV Trial and hereby object to Phelan Piñon Hills Community Services District's Objection to Second Amended [Proposed] Statement of Partial Decision for Phase IV Trial. These objections are based on the following grounds.

Bolthouse agrees with AGWA that the provisions regarding the scope of trial set forth in the Fifth Amended Case Management Conference Statement, should be incorporated into the Statement of Decision to clarify the scope of the Phase IV Trial..
